# **Academic Senate Executive Meeting Minutes**

February 5th, 2021 (convened at 9:06 am) in Zoom

### 1) Public Comment

• Sherry Ackerman asked about the Town Hall meeting being postponed at the last minute. President Ron Slabbinck noted there was no discussion with Senate presidents before making this decision. The survey sent out previously was in response to needing a safe and anonymous place to get feedback from the campus community before the Town Hall meeting. The Special meeting of the Board yesterday was the first time the Board has met since receiving the many comments from the community over Winter break. It would be good if the Board could receive the survey comments before the Town Hall meeting rescheduled for Feb 19th. The survey also needs to be sent out to PT faculty to get their input.

### 2) Approval of Minutes

## 3) Discussion and Action Items

Ron will reach out to a couple of faculty members who could be a possibility for Accreditation, Standard II Team. It is important to identify faculty mentors quickly so we can help our new faculty acclimate to the campus
- b) Discuss "Vickie" replacement regarding Tenure Committee appointments. This item was tabled until we have more information. Evaluations are definitely in our purview, although identifying who in the district will do this work is up to the Instruction Office.

Patrice Thatcher-Stephens noted that the original intent was to keep the focus on anti-racism in the resolution rather than broaden to class and gender etc.

- e) Academic Senate Agenda—The team reviewed the agenda for Monday's meeting.
