## 1) Public Comment

Senate President Ron Slabbinck showed appreciation for the Flex Committee and the work they are doing to bring relevant activities to the Flex days. Senate Vice President Neil Carpentier Alting and Patrice Thatcher Stephens will present the Faculty Handbook in one of the workshops. Ron Slabbinck and Liz Carlyle will attend the Board docs training.

### 2) Approval of Minutes

#### 3) Discussion and Action Items

- a) <u>Discuss Senate goals for Academic Year 2021-2022</u>—Ron Slabbinck shared a list of goals developed from our discussions at the end of last academic year. As we enter the new school year, with shifting Covid pressures and lingering smoke, how can we continue to find pathways to accomplish priorities without burying ourselves, and how can we motivate those who don't feel good about the new year? We have some hard conversations ahead but we want to do it from a positive outlook and not from a place of fear or shortage conciousness. Neil Carpentier Alting added that it's important to recognize the issues at hand (pandemic and college crisis) but hold onto our humanity.
  - Accreditation there will be draft for full review in a month.
  - Implement ideas in the Faculty Handbook. How can we turn it into action?
  - Orientation. Ron Slabbinck and Val Roberts have met and are developing a Canvas shell. Ann Klein suggested a Faculty Resources Canvas shell.
  - Program Approval Process—Interim Superintendent Dr Char Perlas and Neil Carpentier Alting have discussed a few initial steps to establish our process. One first step is to revise AP 4020, which will likely take a few months.
