B. Roll Call 1 minute | Action

1. Spring ASB elections | O'Toole

2. Student Safety Presentation | Johnson

Senators will discuss the proposed presentation or information, which is meant to engage with or educate students on college policy and culture regarding sexual assault and consent, as well as resources available to students through the college and the Weed PD.

4. DSPS Renaming | Herrera-Thomas

This will involve a vote on if ASB will be involved, along with DSPS, in a public name change forum/discussion panel, and planning VP Johnson's presentation for the advisory committee, which will be our proposal for the process of the name change. This time will also serve to plan outreach to the general college population for feedback on the name change.
