Important Information: Please Read

Last week, Keenan & Associates informed us that they had a cybersecurity breach. From the information sent, it sounds like all District & College current and former employees (including spouses and children) have been impacted. If you and your family's data have been compromised, you will be receiving a confirmation letter in the mail from Keenan. The letter will provide information on signing up for a complimentary 24-month membership in Experian® IdentityWorksSM Credit 3B.

The letter from Keenan is scheduled to be sent the week of Jan 22, 2024. In speaking about this incident with Executive Cabinet, we encourage everyone to take a proactive approach. Interim VPAS Van Alfen has provided the information below:

- Learn about your credit report and how to get a copy: <https://www.usa.gov/credit-reports>. By law, you can get a free credit report each year from the three credit reporting agencies (CRAs). These agencies include Equifax, Experian, and TransUnion. Due to financial hardship resulting from the COVID-19 pandemic, you can get a free credit report each week through December 2023. [AnnualCreditReport.com](https://www.annualcreditreport.com) is the only website authorized by the federal government to issue free, annual credit reports from the three CRAs.
