College of the Siskiyous (COS), one of the most beautiful community college campuses in the state, is located at the base of majestic Mount Shasta in far northern California. Established in 1957, the primary campus is located in the historic lumber town of Weed with a second campus located in Yreka, both easily accessible from Interstate 5. Each semester there are between 3,500 to 4,000 students enrolled at College of the Siskiyous.

College of the Siskiyous Welcomes New Superintendent / President

On October 1, 2008, College of the Siskiyous welcomed Randall C. Lawrence, as the new Superintendent / President. Mr. Lawrence is the 9th Superintendent / President for the Siskiyou Joint Community College District.

A native of Portland, Oregon, where he attended Portland State University and Lewis and Clark College, Lawrence graduated with a Bachelor's of Music from Lewis and Clark in 1978. In 1979 he was awarded a full tuition scholarship to attend the College-Conservatory of Music at the University of Cincinnati and completed his Masters of Music degree in 1980. Following graduation, Lawrence accepted a teaching position at Toccoa Falls College in Northeast Georgia and later returned to Cincinnati to begin work on a Ph.D. in Musicology.

Lawrence's community college experience began by serving as a one-year sabbatical replacement at Clark College in Vancouver, Washington. This opportunity opened his eyes to the egalitarian mission of the community college where he has spent the rest of his career. A year later, in 1987, he became Professor of Music at Olympic College in Bremerton, Washington, where he taught nine years in the classroom. In 1996, Lawrence became Dean for Social Sciences and Humanities at Olympic College and served in this position for five years until he was selected to be the Vice President of Instruction, a position he held until recently.

As Vice President of Instruction, Lawrence oversaw over 500 faculty members (113 full-time), a budget of \$22 million, and was responsible for two satellite campuses, three military installations, and a virtual campus for distance education. At the state level, he was co-chair of the body that is responsible for community college to baccalaureate transfer and a board member of the Washington state's professional development organization. In the community, Lawrence served as a member of the Poulsbo/North Kitsap Rotary, Choral Director at Central Kitsap Presbyterian Church, and led the West Sound Educational Leadership Council.

Lawrence's academic interests are in conducting, early music instruments and the transcription of Medieval/Renaissance Music notation into modern notation. He has transcribed and edited, for the first time in history, many of the works of composer Leonhard Paminger (1495 to 1567). He and his wife Jan have two daughters, a son-in-law, and a grandchild.

Having just completed my first year as Superintendent/President, it is exciting to look back and see how College of the Siskiyous has changed. The physical changes are probably the most obvious. If you have been on the Weed Campus you have seen the new Emergency Services Training Center and the new parking lots that were completed last fall. This Vision, based on input received from you last spring as I visited our entire county's communities, is being written to ensure that all our planning is directed towards meeting the educational needs of Siskiyou County into the future.

As you read this report, I hope you can see our desire to join with you in making our county a more prosperous and even better place to live and work. To that end, we continue to commit ourselves to being your College.

Measure A Projects Coming to an End

In November 2005, Siskiyou County voters passed Measure A, a \$31.4 million bond supporting capital building improvements and renovations to meet the future educational needs of the residents of Siskiyou County. The College identified many projects and set top priorities for the funding to be used for new job training programs and academic classroom projects.

A Bond Oversight Committee comprised of members of the community was established and a Project Management Team was hired to oversee the many projects. In May 2006, remodeling of the on-site Residence Lodges began and was completed in time for the fall 2006 semester. Later that semester in November, the College began the "build out" of the Distance Learning Network by adding video classrooms to six high schools in Siskiyou County and upgrading equipment at three high school locations as well as the COS Weed and Yreka sites.

In 2007, extensive work was completed on the Weed Campus: the gym lobby and both locker rooms were remodeled; the bleachers were resurfaced; many of the buildings were repainted; the electrical system was replaced, and the new Tactical Training Center (TTC), a state-of-the-art facility to support the Fire Science Program, was completed by the end of the year. An open house / grand opening was held in February 2008 to celebrate the new facility.

Ground-breaking for the Emergency Services Training Center (ESTC) was held April 2008. During the long summer and fall, construction crews worked hard to make sure the building stayed on track so it would be ready for staff to move in and classes to begin in January 2009. A grand opening / ribbon cutting celebration was held on March 11, 2009. COS faculty, staff and students along with local government officials and community members attended the special event. This facility features state-of-the-art audio/visual equipment and was built using green technology. The space is mainly dedicated to the COS Emergency Medical Technician / Paramedic Program for its extensive coursework and training on how to provide immediate care to the critically ill and injured. In addition, the offices of the Career and Technical Education Department, Environmental Resources Program, and Administration of Justice Program are also located in this new facility.



ESTC Grand Opening - March 11, 2009

Construction on the Weed Campus parking lots began May 27, 2008 and was completed in time for the fall semester. Parking areas near the Baseball Field, Theater, Gym, and Life Science buildings now offer greater safety to the students and staff who park in these areas. Also during the summer of 2008, the building modules for the Temporary Classrooms / Maintenance Building were assembled and work inside and out of the facility was completed.

On June 3, 2008, a groundbreaking ceremony for the new Rural Health Sciences Institute (RHSI) was held at the Yreka Campus. Members of the Board of Trustees, Foundation, Yreka City Council, Siskiyou County Board of Supervisors, Bond Oversight Committee, COS administration, faculty, staff and students were in attendance. Completion of the new facility is slated for fall 2009. The RHSI will house not only the Nursing Program, but will include available space for the creation of several additional healthcare career programs, and will feature cutting-edge simulation technology. Because of this technology and the unique mission of training students on the challenges of rural healthcare, the RHSI is attracting attention throughout California and Southern Oregon.

"The residents of Siskiyou County decided to tax themselves for the benefit of their college. What kind of people would do that? People who care about education... I've continued to see that support in so many ways since arriving at the College last fall," said Randall Lawrence, COS Superintendent / President.

The passage of Measure A is truly providing the students of College of the Siskiyous and the residents of Siskiyou County with opportunities that will enrich their lives for years to come.

New Year, New Trustees

On December 2, 2008, two new members and one incumbent were administered the Oath of Office during the College of the Siskiyous Board of Trustees meeting. The new Trustees, Gregory Hanna of Scott Valley and Barry Ohlund of Yreka, replaced long-time Board members Bill Rowe and Dorris Wood. Incumbent Bob Rice was unopposed during the November 2008 election.

MESA Program Achieves State Recognition

In March 2009, the MESA Program at COS was highlighted in a press release distributed statewide and written by Danielle McNamara, Statewide Communications Coordinator—MESA.

Mathematics, Engineering, Science Achievement (MESA) is an awardwinning academic enrichment program that provides educationally disadvantaged students with the tools to earn bachelor's degrees in math / science based fields. With tutoring and mentoring, extra study sessions, transfer counseling and study centers, MESA provides an environment that allows students to succeed in math and science and navigate the transfer system more easily.

Currently MESA has programs in 31 of California's 110 community colleges and serves less than one half a percent of the one million full-time community college students in the state. At College of the Siskiyous, about one percent of the school's student population is enrolled in the program, but is responsible for about 41 percent of the number of students transferring to four-year institutions. Of the MESA community college students who transfer, 98 percent go to four-year institutions as science, technology, engineering or math majors.

2008 – 2009 College of the Siskiyous Faculty Emeritus Awards

In1984 the Board of Trustees adopted Board Policy 5.13 to award Emeritus Faculty Status to those retired faculty and/or administrators who have made outstanding contributions to the District. During the May 2009 Board of Trustees meeting, the Board approved the nomination to confer faculty emeritus status to three retired faculty members and recognized them during the commencement exercises held May 15, 2009.

Dennis DeRoss is a COS Alum who graduated in 1967. In 1971, DeRoss was hired by COS to work in the Student Services Department and as an assistant baseball coach. During his next twenty-two years at COS, he developed the first Financial Aid Program, EOPS Program, Tutoring Program, and also served as an academic advisor, Director of Relations with High Schools, Veteran's Officer, instructor, assistant football coach and head baseball coach. In 1992, DeRoss became the Director of the Yreka Campus and then returned to the Weed Campus in 1996 as the Dean of Career and Technical Education and Economic Development. In 2006, DeRoss retired from the District and was inducted into the COS Athletic Hall of Fame and was recognized as the first recipient of the COS Distinguished Alumni award.

James "Jim" Ray was hired by the District in 1967 to teach US History. At COS, Ray served as the first head football coach, the College's gymnastics coach and as instructor in a variety of faculty educational activities. He also served as the President of the Academic Senate and Chairman of the Humanities Division. His areas of teaching included Recreation, U.S. History, U.S. Political Institutions, Sociology, and California History before his retirement in 2001. He has also been responsible for extended field trips varying in length from a few days to several weeks covering such diverse areas as Europe, Asia, Africa, South America, Australia, New Zealand, the Pacific Northwest, the Grand Canyon, Death Valley, and Alaska. He has been a recipient of the Teacher of the Year Award and in 2004, was inducted into the COS Athletic Hall of Fame.

Ken Goehring began teaching at College of the Siskiyous in 1975 as an instructor of Biology and Chemistry. While at COS, Goehring taught a number of classes that also inluded Cultural and Physical Anthropology and Physical Geography. He also taught a variety of computer science classes: Computer Literacy, Introduction to Programming, Computer Programming, Web Programming, and Web Publishing. As a member of the faculty, he served as Academic Senate President, Faculty Association President, and was for a number of years Chair of the Academic Standards Committee. In addition to his teaching duties, he also served twice as the Interim Vice President of Information Technology Services and was instrumental in the development and operation of a campus-wide Team Web committee.

COS One of Only 20 Chosen Nationwide to Receive Grant to Improve Economic Opportunity

In October 2008, College of the Siskiyous received notification of being one of only 20 colleges and technical schools nationwide selected by the American Association of Community Colleges (AACC) to participate in the Wal-Mart Workforce and Economic Opportunity Initiative. Each college received an \$86,000 grant to partner with its local workforce development community to improve the community's economic prosperity and help people live better. The award recipients were announced following completion of a highly competitive application and evaluation process.

"We are thrilled to receive this award from the Wal-Mart Foundation," said Randall Lawrence, Superintendent/President of College of the Siskiyous. "This initiative will allow us to support continuing education and training for the rural health care community in Siskiyou County," he continued. The College of the Siskiyous is currently building a Rural Health Sciences Institute (RHSI) at its Yreka Campus to more effectively deliver critical health care training throughout Siskiyou County, California. The *Wal-Mart Workforce Economic Opportunity Initiative* will bring together economic development groups to create a business and implementation plan for the RHSI, which will include a system for delivering health care training through the production of a web-based continuing education program.

AACC President George R. Boggs expressed particular appreciation for Wal-Mart's vision in launching an initiative that targets many isolated, rural communities. When operational, programs will serve as models for the more than 800 rural institutions comprising two-thirds of AACC's close to 1,200 college membership. "We congratulate these colleges and look forward to the initiative's impact to revitalize communities and regions," Boggs said. "With Wal-Mart's support, this network of pilot projects will provide innovative and sustainable partnerships that expand the capacity of community colleges to spur economic growth."

College Begins Development of 20-Year Vision Statement

In this age of short-term thinking and constant problem-solving, we don't often give our self the opportunity to "dream" our future. Because of shortterm tendencies, planning seems to be constantly changing instead of being focused on long-term goals, such as in the 1960s when the government planned to put a person on the moon within a period of ten years. The College of the Siskiyous would like its strategic planning process to be focused on just such a vision.

During annual Planning Day activities held November 2008 and April 2009, the College of the Siskiyous staff, faculty and administration began work to define their vision for College of the Siskiyous twenty years from now. At the November meeting, President Lawrence discussed how crucial it is to have a clear, long-term vision of where COS should be headed in the future. In January, a "task force" of COS personnel representing all the campus constituent groups were identified. One of the duties of the Task Force was to plan activities to be held during the Spring Planning Day in April. The Task Force then took comments and input received during Planning Day activities and began organizing the information.

As the "Community's College," COS believes this vision must also be informed by the citizens of Siskiyou County and their dreams for the future. During the months of May and June 2009, President Lawrence and members of the COS Board of Trustees visited the communities of Siskiyou County and held open forums inviting the residents to attend and share their dreams and aspirations for their community and the county as a whole and what role the College could play in accomplishing them.

During each forum, President Lawrence spoke of how important the community's input is to the future of the College. "A vision for COS needs to be informed by every employee at the College and every stakeholder in the community. If it is done right, that vision will not only be relatively free of a president's fingerprints, but should continue on long after the individual has left. In fact, it should have everything to do with who is chosen to lead COS in the future because they will be asked to lead a college that already knows where it is going and is looking for a leadership style that will get them there," said President Lawrence.

The Vision Task Force continues its work, and at this time is about 2/3 of the way through the process of writing the Vision document. A draft of the document is expected to be released for the first review by the end of August. It is expected the final document will be ready for adoption by the Board of Trustees by the end of the year. "Yes, the details of planning will change over time as circumstances change but the long-range vision will continue to inform that planning throughout the years," said Lawrence. "Strategies, organization, funding and other factors will see change over the years, but not the central vision."

Historic Season: Eagles Repeat 20-0 GVC Record

In 2008, the Lady Eagles Softball Team posted a perfect 20-0 record on the way to winning the Golden Valley Conference (GVC) title. This year they made history by going 20-0 for a second consecutive year in the GVC.

Ranked No. 1 in the state with a 41-3 record, the Eagles were the No. 1 seed in the Northern California playoffs which they started at home against No. 16, Yuba College on May 2. The top-seeded College of the Siskiyous Lady Eagles pushed their record to 43-3 with a sweep of the



Yuba 49ers in the first round of the Northern Region playoffs (5—0) and (11—1). They then went on to play against No. 10, College of the Sequoias in the second round of the Northern Region playoffs winning (9—1) and (9—0) on their home turf and advancing the team to the eight team California State Championships in Salinas for the second consecutive season.

After knocking off Riverside and Sierra, the Lady Eagles were matched up against defending state champion Mt. San Antonio in the semi-final. COS lost the game against Mt. San Antonio, but still had the opportunity to play in an elimination game against Sierra College. COS had already won against Sierra twice during the season including the day one tournament victory, but strong pitching by Sierra kept the Lady Eagle offense at bay and sparked by two home runs giving Sierra the victory. The loss eliminated the Lady Eagles and capped their season with a 47-5 overall record.

On May 14, 2009 members of the Redding Fire Fighters Association presented Tony Osa, COS Fire Technology Program Coordinator, with a donation of \$1,666 to support the COS Fire Technology Program in memory of Captain Ed Andrews, a former COS Fire Technology Adjunct Instructor who passed away in 2008.

2008 – 2009 Grants

In September 2008, Board Policy 3280 (Section I: Governance; Subject: Grants) was adopted by the College of the Siskiyous Board of Trustees. The policy requires the Board be kept informed of all grant applications made and grants received by the District. Below is the list of grants received during 2008-2009 which received funding:

- \$2,326—California Early Childhood Mentor Program Grant: This renewal grant will continue to provide travel funds for Early Childhood Education (ECE) Program mentors to travel to mentor sites in the remote parts of Siskiyou County.
- \$3,000—Ford Family Foundation: Funding will provide for a planning grant to establish a building planning process and funding strategy for the remodel of the Kenneth W. Ford Theatre.
- \$15,000—Ford Family Foundation Grant: To provide renewal funding for Ford "JumpStart" Program students to be successful in their academic careers.
- \$17,487—Faculty Inquiry Network Grant: Administered by Chabot College, this grant is funded by the William and Flora Hewlett Foundation. It will increase awareness of the culturally diverse COS student population as well as validate basic skills students through the use of video footage.

- \$40,000—Song-Brown Nursing Grant: Will support the LVN to RN Step-Up Program providing funds for recruitment and travel; adjunct faculty salaries; and the purchase of equipment and educational supplies.
- \$81,500—MESA (Math, Engineering, Science Achievement) Renewal Grant: Will provide comprehensive academic support services, as well as educational and personal counseling to students seeking careers in math, science, engineering and computer science fields.
- \$100,000 (includes \$14,000 in technical assistance) AACC's Building Better Communities Grant: The Wal-Mart Foundation will provide funding to bring together major economic development groups from the region to develop a business and implementation plan for the Rural Health Sciences Institute.
- \$181,472—Governor's Discretionary WIA Funds: Workforce Investment Act funds will be used to begin additional cohorts of 20 LVN students and 15 CNA students at the Rural Health Sciences Institute in the fall of 2009.
- \$198,200—CCCCO Renewal Capacity Building Nursing Grant: To support personnel for the LVN to RN Step-Up Program as well as instructional equipment and supplies.
- \$289,430—USDA Rural Development / Distance Learning & Telemedicine Program Grant: To support the purchase of distance learning equipment at the Rural Health Sciences Institute (RHSI) in Yreka and the Emergency Services Training Center (ESTC) on the Weed Campus.
- \$324,398—Upward Bound Renewal Grant: To support personnel for the Upward Bound Program as well as travel, food and lodging expenses for students during the program's annual six-week summer program.
- \$395,932—U.S. Department of Education Title III Renewal Grant: To increase student services and academic support for improving academic success, enrollment, and retention.
- \$400,000—Chancellor's Office CTE Community Collaborative: To continue expansion of the Environmental Resources Career Pathway Program at College of the Siskiyous for the period of 2/1/09 through 8/31/10.

Mission of the COS Foundation

The COS Foundation supports the mission and values of the College of the Siskiyous by fostering community relationships and raising funds to enhance exceptional learning environments.





Funded Educational Grants & Projects

\$1,000 awarded to the Yreka Campus to be used for the establishment of the Yreka Campus "Textbooks on Reserve" program for students who are unable to afford textbooks.

\$1,000 awarded to the Administration of Justice Program to purchase new floor mat safety equipment to provide protection to students involved in the COS Administration of Justice Programs and required Police Officer Standards and Training (POST) Perishable Skills coursework. The new equipment will bring the ADJ Program and POST Perishable Skills training up to appropriate safety standards as well as allow for expansion of course offerings and inclusion of more students.

\$1,000 awarded to the Maintenance and Print Services Departments for the purchase of new Rubbermaid Square Brute Big Wheel recycling containers and label stock for use by the COS Recycling Program.

\$500 awarded to the Music Department to purchase one MBBOX Academic Digital Interface with Pro Tools Software packet and one set of Sony MDR 7506 Headphones. Music technology is one of the most requested areas of interest by COS students majoring in Music.

\$461 awarded to the Athletic Department to purchase a new DVD Burner for the Athletic Department. One of the department's goals is to help COS students transfer to four-year institutions after they have graduated from COS. The DVD Burner is used immediately following each sport that is in season by the coaches to provide a better quality and more efficient way of developing game film which is then sent by the student athletes to four-year colleges and universities showcasing their talent.

\$986 awarded to the Chemistry Department for the purchase of new Chemistry equipment. New equipment items included: Spectroscope, Spectrum Tube Power, Periodic Table of Elements, and Spectrum Analysis Chart. This new equipment has helped to make the program stronger and more competitive with other chemistry programs.

Scholarships Awarded 2008-2009

The COS Foundation awarded \$11,850 in financial support for the 2008-09 academic year. As part of its commitment to student success, the Foundation annually awards scholarships to students who have a need for financial assistance. While each student's story is different, each shares a common theme of having a desire to begin or continue their education. Recipients can be high school students entering COS, single parents striving for self-sufficiency, students supporting themselves without parental assistance, or those with special needs who meet the eligibility criteria.







2008-2009 Honored Award Recipients

Lawrence Moran Distinguished Service Award

The 2008-2009 Lawrence Moran Distinguished Service Award was presented to Rand Roselli of Weed. Since retiring from Cal Trans and moving to Siskiyou County in 2000, Rand has spent much of his time in community service. His relationship with the COS Foundation began in 2001 when he became the annual Summer Farmer's Market Manager and then officially became a member of the Foundation in April 2002. Since joining the COS Foundation, Rand has served as the Farmer's Market Manager, Firewood Sale Coordinator, and member of the Performing Arts Series, Scholarship, Dinner Auction, Golf, Investment Due Diligence, Fund Development, and Executive Committees. From 2004 to 2006, Rand served as Vice President and then as Foundation President from 2006 to 2008. One of his favorite activities with the Foundation harkens to his Cal Trans days — he loves to gather and "buck up" wood for the annual firewood sales.



In addition to his work with the Foundation, Rand has taken classes offered by the College including guitar and yoga. In addition to his devotion to the College and Foundation, Rand has been a volunteer for the Mercy Auxiliary Foundation since 2003. Rand has served as Vice President and President of the Auxiliary, and for the past four years has been in charge of registration for their annual golf tournament. Recently, Rand joined the Siskiyou County Development Council as a board member.

COS Partner of the Year Award

The recipient of the 2008-2009 COS Partner of the Year award was the McConnell Foundation of Redding, California. The McConnell Foundation was formed by Carl and Leah McConnell in order to share the benefit of their lifelong accomplishments. Since 1989, the McConnell Foundation has awarded more than \$125 million to support Northern California projects in the areas of Arts & Culture, Community Vitality, Recreation, Social Services, and the Environment. In 1999, they began an international program and now fund in the countries of Nepal and Laos. Through the uncommon generosity of Carl and Leah McConnell, the McConnell Foundation is known as a philanthropic organization positioned to help build better communities today and for future generations.

College of the Siskiyous has benefitted greatly through grants received from the McConnell Foundation. In 1997, support for the renovation of the Weed Campus Track and Tennis Courts was awarded, followed by funding for the Leadership Siskiyou County project. In 2003, the McConnell Foundation supported the College's partnership with Southern Oregon University to offer a Bachelor's Degree Completion Program. Most recently, the COS Foundation was awarded a five-year mirror grant to support the Rural Health Sciences Institute Endowment Campaign. The mirror grant will contribute dollar for dollar matching funds raised by the COS Foundation in support of this campaign, approximately \$80,000 per year or \$370,000 during the five-year period.



COS Distinguished Alumni Award

Larry Alexander, of Etna, is the 2009 COS Distinguished Alumni. Since attending COS in the late 1960s and early 1970s, Larry has enjoyed a successful career in recreation management and natural resources. A leader in the development of new vocations in natural resources, Larry has also found a way to meet the changing needs of public and private landowners in response to new legislation affecting resource lands. In 1996, Larry and his team created the Northern California Ecosystem Training Program (NorCET), a model that has been replicated in several Northern California counties. NorCET was a successful partnership of several local entities, including COS. Larry's ability to overcome many challenges was critical in the effort to preserve the beauty of Northern California while providing economic opportunity to families who live here.

When federally sponsored training grants could no longer support the work of NorCET, Larry would not accept defeat. The Northern California Resource Center, located in Fort Jones, and of which Larry is the Chief Executive Officer, is the result of his effort to create an independent nonprofit organization to continue the training and the quality of work for which he and his team have become known.

Larry is also a "world-famous" musician and is enjoying the new-found status and the chance to make music and have fun with good friends. He is an advocate of lifelong learning and an unofficial spokesperson for COS.
