I. Approval of Minutes – October 27, 2020

It was moved and seconded (Clarke/Korkowski) to approve the minutes. Motion carried unanimously.

II. Course Revision for Approval – For DE Addendum Only (Elwood)

a. BIO 2200 – General Bio II – Life & Ecology

i. Effective Date: Spring 2021

ii. Submission Rationale: Add DE Addendum

In order to get BIO 2200 included in the Spring 2021 schedule, the course was approved via email last week.

b. <u>COMS 1300 – Interpersonal Communication</u>

i. Effective Date: Spring 2021

ii. Submission Rationale: Add DE Addendum

It was moved and seconded (Clarke/Knudsen) to send the COMS 1300 course back to the originator because there were more than just DE changes to the course. Motion carried unanimously. The originator will be asked to change the submission reason and rationale to note all areas of the course that are being revised.

a. PEMA 1006 - Men's Varsity Basketball

c. HEA 1009 – Human Sexuality

ii. Submission Rationale: Course Description, Methods of Instruction, Textbook, Other Instructional Methods, SLOs, Add DE Addendum

The basketball classes are usually scheduled for 1.5 units over 2 semesters. Adding the 3-unit option will allow flexibility to offer the courses in one semester when needed. The Articulation Officer will need to update this change in ASSIST.

It was moved and seconded (Clarke/Kephart) to approve PEMA 1006, PEMA 1014, and HEA 1009. Motion carried unanimously.

IV. Program/Certificate Creation (in Elumen) for Approval Elwood)

a. Physical Education

Faculty in the area worked on getting this program entered in Elumen in Spring 2020 when it was requested that Faculty enter their programs into Elumen. Charlie commented that the process for entering is pretty straightforward.

b. <u>Computer Science</u>

This program has too many units for an ADT and will need to be sent back to originator to

revise.

c. Game Design Certificate

Elaine reported that the originator had requested that this certificate be archived because some of the courses are not being offered.

After some discussion and the program approval process, Curriculum Committee requested clarification on what their role is in approving programs in general, and particularly in Elumen. When programs are entered into Elumen, will the Curriculum Committee be taking action on them or will they be an information item.

The current workflow in Elumen has the following stages: Originator, Dean, VPI, Curriculum Committee, Curriculum Chair, Curriculum Specialist.

It was noted that programs are considered a "course of study culminating in an award." For example, in Elumen you would enter 3 separate program workflows for a COS AA, ADT, or a Certificate.

Since there are a number of program workflows that have been in Elumen and many are still at stage 1, the Committee recommended an email be sent to faculty reminding them to check their programs and if they need assistance that there is a video that takes you through the steps of entering programs in Elumen. It was also suggested that Dean's discuss at their respective area meetings.
