Notify them that you need to be fingerprinted in Siskiyou County for College of the Siskiyous. They will ask for the **ORI# A0454** and the **Agency Billing# 141117** from your Livescan form.

NOTE: On the day of your appointment, confirm with them that you only need DOJ Clearance, not FBI or Child Indexing.

Fingerprint Policy

College of the Siskiyous is aware that you may have been fingerprinted prior to today, and possibly for another purpose within the College itself. Unfortunately we are unable to share fingerprint results for the following reason.

An Information Bulletin from DOJ states: "Section 1105 of the Penal Code authorizes the DOJ to furnish criminal record information to various agencies/entities to assist them in fulfilling their employment, licensing, and certification responsibilities. The agency's use of the record information shall be restricted to the sole purpose for which it was requested. The information may not be reproduced for secondary dissemination to any other employing or licensing entity."
