- 1. SENATE RESOLUTION PROPOSAL FROM THE DL COMMITTEE
 - i. In order, to ensure academic quality, student learning, and institutional effectiveness in distance education at COS, an orderly and well-planned transition to Canvas LMS, and to ensure adequate time for implementing student, staff, and faculty training, as well as time to migrate courses from Etudes to Canvas, we, the Academic Senate, support joining the April 2016 Canvas cohort. Course offerings in Canvas would not begin until Fall 2017. (Approved unanimously)

F. DISCUSSION ITEMS

- 1. Policy on students who are 15 and under in college classes: a lengthy discussion occurred about changes to the District's policy on permitting children 15 and under to take courses at COS. Currently, children 15 and under need an instructor's permission to enroll in a class. The District wanted to change the permission to the VPI. The faculty listed a broad range of concerns with allowing children 15 and under into college classes, including:
 - a) maturity level of students
 - b) the potential for introducing student to content that may not be suitable for children 15 and under faculty do not have the training need to teach that age group

The VPI agreed that that counseling would act as the gatekeeper and work with faculty to generate list of courses that would be appropriate for that age group. The counseling office will also work closely with instructors when making decisions on adding children 15 and udder into classes.
