## \*\*\*Resolution #5\*\*\* - College of the Siskiyous Academic Senate Resolution: Faculty Assignment of Grades

Whereas grade assignment(evaluative and non-evaluative) is under the purview of the faculty;

Whereas § 55205 of Title 5 of the California Code of Regulations states that, "In any course of instruction in a community college district for which grades are awarded, the instructor of the course shall determine the grade to be awarded each student in accordance with this article."

Whereas the Educational Codes Section 76224 states that, "When grades are given for any course of instruction taught in a community college district, the grade given to each student shall be the grade determined by the instructor of the course and the determination of the

Be it therefore resolved:

The Academic Senate affirms that grade assignment (evaluative and non-evaluative) is the prerogative of the faculty. Under Title 5, the California Education Code, and its own administrative procedures, Administration must accept and adhere to the grade assignments made by faculty.
