Retired faculty who have made outstanding contributions to College of the Siskiyous are eligible to receive the title Emeritus Faculty in recognition of those extraordinary achievements.

I. Nomination and Selection

- a. Must be nominated by a tenured member of the Academic Senate.
- b. Deadline for submitting letters of nominations is November 1.
- c. Submission is made to the President of the Academic Senate.
- d. The nomination will include a formal letter addressing the established criteria and any documentation that supports the nomination.
- e. The Executive Committee will review the nominations and make a recommendation for each.
- f. The recommendations of the Executive Committee will be submitted to the Academic Senate for review at the first meeting of the spring semester.
- g. Upon approval by the Academic Senate, the names with a one-page summary listing their contributions to the District, will be forwarded, via the President's Office, to the Board of Trustees for possible personnel action by the March Board meeting.
- h. Approval by the Board will confer the emeritus status.
- i. Unsuccessful applications may be resubmitted in subsequent years.

II. Criteria

The criteria for selection shall include but not be limited to:

- a. demonstrated excellence in teaching.
- b. service to students outside of the normal classroom environment.
- c. service to COS by way of on-campus, community and/or statewide involvement.
- d. service to faculty.
- e. professional involvement, awards or recognition they have obtained while at COS.
- f. provided leadership to other members of the Faculty.

III. Qualifications

In order for a retired faculty member to be eligible for nomination for emeritus status, the retiree shall:

- a. have a minimum of 15 years of service;
- b. have been retired from full-time faculty duty for at least one academic year prior to the nomination; and
- c. not continue to work full-time in the field of public education.

IV. Benefits and Burdens

Individuals designated as emeritus to College of the Siskiyous will:

- a. be awarded appropriate recognition of "Emeritus Status" upon its original receipt at the next graduation exercise;
- b. have the award announced to the community via public and social media;
- c. receive a plaque indicating the recognition;
- d. have a photograph, brief history, and description of the contributions made to the College of the Siskiyous displayed in an appropriate location on campus; and
- e. be listed as emeritus faculty in the College of the Siskiyous catalog.
