  - a. None
- 2. Reports/Discussion
  - a. Workgroup Reports:
    - DL Participation and Drop Guidelines for Senate Review and Approval (Bellamy and Carlyle): Initial meeting with Sherice and Liz to create a plan: look at CCCs across the state and select a model that works for us; attendance is an institutional decision and definition, and it considers Title V; policy must be clearly stated in the syllabus; items to think about:
      - a. create a list of colleges to look at, small and large;
      - b. what are the implications for financial aid;
      - c. define participation—review the Title V guidelines for regular and substantive interaction;
      - d. maybe create template emails;
      - e. create a policy for first week, for census, and ongoing philosophy.
    - 2. DL academic integrity/proctoring/authentic assessment guidelines for Senate Review and Approval (Zeller, Thomsen, and Varty):
      - a. What can we do to expand the definition and process of ensuring academic integrity;
      - b. proctoring software is just one avenue;

- c. Zeller mentioned that ASC is not a distraction-free space; Baldwin mentioned the library spaces may be quieter.
- d. Varty mentioned that examples are a great idea; fernandez mentioned Authentic Assessment toolbox and @One resources for examples
- 3. OER/ZTC increase awareness and adoption (Baldwin): Baldwin and group will meet on Thursday 12/9/21; group has expanded to include Jayne Turk and David Blink; Baldwin mentioned that potential topics of discussion include:
  - a. we should create a local definition of ZTC and low-cost if we don't have one;
  - b. there is a financial incentive for adopting OER;
  - c. there will be a flex session on OER;
  - d. OER/ZTC is now a search parameter in Banner online schedule.
- 4. Online Faculty Evaluation—purpose, process, and roles for Senate and FA Review and Approval (Tischler and Fernandez): Work group hasn't formally met; Tischler and Fernandez will work on online faculty evaluation language. The group discussed that in the new contract one of the flex days should be to related to training and aspects of the evaluation process
- 5. Course Design Academy increase awareness and participation (Fernandez): Fernandez shared progress with Professional Development Portal.
