### **Approval of Minutes**

Shannamar moved to approve the minutes from May 12, 2025, with the addition of Shannamar in attendance. Kyle seconded. Approved with one abstention.

### **Discussion / Action Items**

- Fall Flex workshop Insights Training. Debrief and identify areas of need for further training or support for faculty
  - There are technical issues resulting in incorrect outcomes. It is unclear how much other work beyond dealing with incorrect outcomes that faculty able to get done.
  - There was a suggestion for mid-semester workshops (SLO study hall?) to help faculty add outcomes to rubrics and get assessing. Another option could be for small groups to work on SLOs with an expert on hand.
- Updates
  - Liz and Ann are meeting regularly with the Deans and VPAA.
  - A new Insights update should correct all ratings scales.
  - It was discovered that Name and Course Code are swapped in Canvas shells. This is causing an issue with the system recognizing Outcomes for courses. We are working with IT to correct this
  - All but one instructional faculty member and the counselors are not Canvas trained and do not receive Canvas shells. We want to make sure we're supporting faculty who don't use Canvas regularly.
  - JT and Ethan have created a data dashboard in ZogoTech. Liz and Ann will meet with JT to review it. The dashboard will require a major data load, so we need to decide on a schedule.
  - We discussed the due dates for assessment. They are currently due when grade back up is due, which is also when Canvas shells close and assessments can no longer be scored.
  - We discussed how we can combine the first two-years of data from eLumen with the third-year data in Insights. JT and Ethan could make a separate dashboard to support dialogue in Fall. We could focus the discussion on revising outcomes and outcomes versus objectives.
- Committee Membership and Goals for 2025-26
  - We created tentative goals and will solidify them at our next meeting.
