2025-2026 Federal Direct Parent PLUS Loan Application Instructions and Information

The Parent PLUS Loan is a loan for the biological parent, custodial stepparent (if information was reported on the FAFSA), or adoptive parent of a dependent undergraduate student.

Interest Rate

The Parent PLUS Loan interest rate begins to accrue at the time of each loan disbursement.

Current Federal Loan interest rates.

Loan Fee

A loan origination fee is charged by the U.S. Department of Education for processing the Parent PLUS Loan. This fee is deducted proportionately from each disbursement of the loan.

Loan Fees

Credit Check

In order to borrow a Parent PLUS Loan, you must pass a credit check. After the signed loan application is received, the Common Origination and Disbursement Center (COD) will perform a credit check and notify you of the results by mail.

Student Eligibility

Before any Parent PLUS Loan proceeds can be disbursed, the student must be:

- Enrolled at least half-time (6 credit hours)
- Enrolled in a degree-seeking program
- Maintaining satisfactory academic progress

Disbursements

Loan funds have two disbursements per term (two in Fall and two in Spring). Loans will pay any outstanding balance in the student's account first and the remaining funds will be distributed based on the parent's selection at the time of applying for the Direct Plus loan.
