- d) Ms. Melby attended a budget workshop recently. State funding module for colleges will stay the same, this will give colleges a chance to figure out the current funding formula. The online college is a mess and will be audited. The administration has been removed.

- f) Ms. Melby reported, COS has State approval for \$27 million dollars to redo the theater, but the District will be responsible for a 20% match. The District plans to file a hardship with the State to waive the 20% match.
