### 2. Presentation: Monarchdipidity

Mr. Blink and Dr. Jaramillo presented a monarchdipidity course for arborists to study monarch butterflies in Mexico and their migration to the United States. This would allow students to be able to livestream the sounds of nature and study the butterflies.

## 6. College / Campus Update

Dr. Schoonmaker provided the following campus update:

- 1. California Athletic Association has approved colleges to compete in athletics in the spring depending on COVID. We have had 180 athletes on campus this fall training for sports. Athletes will not lose their eligibility if competition is canceled in the spring.
- 2. Shakespeare's Greatest Hits will be performed through our Theater department via zoom on Nov. 20 & 21.
- 3. At Thanksgiving all non essential classes would be going online. Yesterday we learned we have 3 confirmed COVID cases and some unconfirmed waiting to here. If more than 3 cases, we move to the next color phase which is orange at this time. If 6 or more cases, we will close the campus to everyone except essential employees and classes. Police Academy and the nursing program end Nov. 20th.
- 4. Working hard on a fire tower prop, that needs replacing.
- 5. Moving forward on the Fine Arts Construction project.
- 6. Kick off meetings are being held for the Housing project, to build 400 more beds on campus. Housing is an issue in our county.
- 7. Nursing has had some turnover, the director retired and two faculty members have resigned. We need four full time faculty and we are down to one faculty. The District is aggressively recruiting for new nursing faculty.
- 8. Dr. Schoonmaker met with Dr. Michael Crow, President of Arizona University, regarding 'How to serve the full spectrum of students'. Dr. Crow has written a few books on higher education.
- 9. Athletic students and staff are tested for COVID once a month. A quarter of the group are tested each week. We are not going to be able to continue with the current doctor office for testing and will be looking into a new system.
