Action, Information: B. Executive and Board Governance

Dr. Schoonmaker informed the Board, there would not be a need to borrow money from the Foundation to start the Enterprise Foundation. There is an anonymous donor to help with start up costs. A letter of intent for legal services from an attorney is being drawn up and the steps to follow for start up are included within the engagement letter.

Information: C. Enterprise Operations - The Eagle's Nest

Ms. Keen reported the number of customers in the Shop has been reduced due to state protocols. The Shop is not taking clothing donations at this time. Three students and eight volunteers are currently working. Cheri Young and ECI Flooring gifted a \$20 gift certificate for each volunteer since we canceled the Volunteer Holiday Party. Ms. Keen is having surgery on Dec. 14th and will be out until February 1st.

Information: D. Scholarships

Crystal Geyser Roxanne, Weed donated \$60,000 to the Foundation, \$50,000 towards Siskiyou Promise and \$10,000 for transfer scholarships to local students who will be transferring to universities from COS, in fall 2021. They are willing to help more if needed.

2021/2022 Scholarships will open in January and may be applied for through March 15th.

Ms. Slabaugh announced the Foundation has applied for the Finish line scholarship grant. The Foundation has applied for \$150,000 for student emergencies for spring semester, not sure how much we will receive. Funding will be used to support emergency grants up to \$1,000. There will be funding available for next school year that we can also apply for.

Action, Information: E. Donor Development Mr. Gault reported he would like to chat with President Deutsch regarding some thoughts he has on Donor Development.

North State Giving Tuesday was December 1st. The Foundation raised \$4,601 from 33 donors.

The Holiday Craft Fair was closed down after two hours due to the wind. It became unsafe. We did refund vendors, some still donated their registration fee to the Foundation. Received \$401 for the COS Student Food Pantry. Thank you to our volunteers.

Action, Information: F. Alumni Association

Bruce reported on the Virtual Alumni Reunion. It was a great success. Not a huge turnout, but was great to catch up with alumni. Found some leaders who can put together events for their area. Everyone learned a lot through the process. Madeleine and Rennie provided feedback for improvement. A follow up meeting will be scheduled with the committee for future events.

Information: A. Cradle to Careers for Siskiyou (C2C4S) Update

Ms. Slabaugh provided an updat on C2C4S. Over the course of the past year, the group got up and running and decided how will it engage the community. They hired an interim coordinator for the committee. Did a live radio interview in Redding and explained what C2C4S is. Had a launch event with over 50 participants and a guest speaker.
