C. Enterprise Operations - The Eagle's Nest

Interim Supervisor, Ms. Maldonova has been ill for the last month and Ms. Slabaugh has had to fill in at the Eagle's Nest. There have been a lot of hurdles to jump through last month. The hours of operation were changed to 12 - 4 PM for the month of October. The plan is on November 1 the Shop will resume normal hours 10 AM - 4 PM. D. Scholarships

Ms. Slabaugh reported four scholarship students did not enroll and therefore did not receive a scholarship. Two of those scholarships were awarded to alternates. Finish Line Emergency Grants and Scholarships will be issued to students for the fall semester.

The Foundation also received a \$10,000 Wildfire Grant to help students and staff who have been affected by one of the fires. Ten grant awards will be paid out at \$1,000 each. Funds must be awarded by December 31, 2021. Unused funds need to be returned.

The Foundation received an email from a donor who would like to donate \$50,000 to establish a welding program endowment for scholarships. Two welding scholarships will be offered, \$2,000 scholarship for a student. The donor's son attended COS and is now a high level welding inspector.

Ms. Shaffer reported on the UTV Raffle and how it is going. Tickets have been sent out to Board Members and will be sold at various events and the Sportsman's Expo in the spring.

5. College / Campus Update

A. College Update

Dr. Perlas gave a brief college update:

The College has been working on the Accreditation report. It will go through the Participatory Governance Process shortly and is due to the state by July 1, 2022. College of the Siskiyous is one of the pilot colleges to go through the new process. On October 20 the Accreditation Report will be posted online.

COVID requirement Board Policies and Administrative Procedures are going through the Participatory Governance Process right now for approval at the November 16 Board meeting.

There will be a COVID vaccine clinic tomorrow on campus from 10 AM - 1 PM and another one on November 10.

Mr. Sbarbaro asked about the current COS FTES this year and how will that affect the budget. Ms. Melby explained the College is currently in a Hold Harmless Agreement until 2025, therefore the College budget will not be impacted this year or the next school year, but we need to be strategically planning for the future.
