## 1. Meeting Opening

A. Call to Order, Roll Call, Introduction of Guests. Meeting was called to order at 5:32 p.m.

## 2. Committee Reports

#### A. Investment and Finance

Ms. Slabaugh sent out the quarterly report and projection to the board. Mr. Sbarbaro advises the Board to ride out the volatile market right now. Once a new Vice President of Administrative Services is hired, a new signature card for the Foundation Investment accounts with Sand Hill will need to be signed.

#### B. Executive and Board Governance

1. C2C4S - Ms. Caldwell gave a brief update on C2C4S activity. She provided a written report for the Board to read. C2C4S supported four local entities with grants for their programs, like summer camps. Ms. Caldwell participated in Eighth Grade Inspiration Day at the College and commended the COS Staff on a job well done.

Ms. Slabaugh reported we need to move forward with a consultant for the next fiscal year since our contract is up at the end of June. We would like to extend the contract for another three months or until a C2C4S director is hired. The C2C4S committee members have approved extending Marie Caldwell's contract for another three to six more months.

The College has been working with Siskiyou Child Care Center to partner with our ECE program. The money will go towards the ECE program and direct services to students.

### C. Enterprise Operations - The Eagle's Nest

### D. Scholarships

- 1. 2021/2022 Finish Line Scholarship and Emergency Grants for Students The Foundation received \$125,000 for student grants and scholarships for the 2021/2022 school year. All \$125,000 has been expended to students.
- 2. 2022/2023 Finish Line Scholarship and Emergency Grants for Students The Foundation is receiving another \$125,000 for student grants and scholarships for the 2022/2023 school year in the fall.
- 3. 2022/2023 Scholarship Awards All student recipients have been notified of their scholarship award by mail or high school awards night. Ms. Slabaugh and Ms. Shaffer traveled to Happy Camp to present a scholarship. The Foundation has awarded five students the \$1,000 Legacy Scholarship and those students are required to work at the Eagle's Nest Shop for a certain number of hours.
- Ms. Green thanked the Board for the three scholarships her daughter received.

Ms. Slabaugh is working with a family to establish a new scholarship. The Scroggin Family has also reached out to reestablishing the original Scroggins Scholarship with a donation of \$10,000 now and putting the COS Foundation in the family's bequest.

1. Update on UTV Raffle – Ms. Shaffer reported UTV tickets are slowly selling. The Foundation will have a booth at the Foundation Flea Market and at the

Siskiyou Golden Fair to sell more tickets.
