- a) **Executive and Board Governance** The Board will hear a report on Board Governance and take action if appropriate.
 - Cradle to Careers for Siskiyou (C2C4S) / K16 Collaborative Quarterly Update. –
 Marie Caldwell represents the Far North on a statewide team for The Cradle to
 Careers Coalition. This team consists of Promise Neighborhood partnerships and
 the Strive Together Partners to communicate to our state legislators the
 progress toward Cradle to Career outcomes.

K16 subgrant partner updates – Mt. Shasta High School implemented the First Responder pathway, linked to College of the Siskiyous Emergency Responder pathway. Montague Elementary began the middle school Health Occupations Career Exploration pathway.
