- Cradle to Careers for Siskiyou (C2C4S) / K16 Collaborative Quarterly Update – Regina Hanna was not present but provided a written report. Highlights included the Klamath River Study Raft Trip, SiskiyouWorks update, and the GSK Science Programming.
- Investment Due Diligence Committee Quarterly Update – Ms. Slabaugh shared with the Board that Foundation Investments are holding steady with a combined account balance of \$4,644,902 for the 2nd quarter.
