NOTICE IS HEREBY GIVEN that the Siskiyou Joint Community College District ("District") will receive sealed Bid Proposals from **prequalified general contractors** for the construction of the Theater Arts and McCloud Hall Reconstruction ("Project") on the College of the Siskiyou campus, located at 800 College Avenue, Weed, CA 96094.

1. **Bid Submission Deadline.** All Bid Proposals must be received by the District no later than March 26<sup>th</sup> 2026 at 3:00pm at:

Bids will be publicly opened and read aloud immediately thereafter.
2. **Mandatory Job Walk.** A mandatory job walk beginning at 10:00 am, Wednesday March 11th, 2026, at College of the Siskiyou, Building 11, Gym Annex, 800 College Drive Weed, CA 96094.
3. **Questions.** All questions regarding this Project must be submitted in writing to Veronica Rivera ([vrivera@siskiyous.edu](mailto:vrivera@siskiyous.edu)) **AND** Nick Trover ([nicktrover@trovercpm.com](mailto:nicktrover@trovercpm.com)) no later than 4:00pm Wednesday March 18th. Responses will be provided to all prequalified bidders via addendum.
4. **Pre-Qualified Bidders Only.** In accordance with Public Contract Code §20101, only contractors who completed the District's prequalification process and were deemed prequalified are eligible to submit Bid Proposals for this Project. Bids submitted by non-prequalified contractors will not be accepted.
5. **Project Description.** The Project generally consists of the reconstruction of the existing Theater Arts and McCloud Hall buildings.
6. **Plans and Specifications.** Bid documents, including plans and specifications, are available at: <https://www.siskiyous.edu/maintenance/>
7. **Contractor's License.** Bidders must possess, at the time of submission of their bid, a valid and current California Class B Contractor's License.
8. **DIR Registration.** Bidders and all subcontractors must be registered with the Department of Industrial Relations pursuant to Labor Code §§1725.5 and 1771.1. This Project is subject to DIR compliance monitoring and enforcement.
9. **Bid Security.** Each Bid Proposal shall be accompanied by a bid security in an amount not less than ten percent (10%) of the maximum amount of the Bid Proposal.
10. **Prevailing Wages.** The successful bidder shall comply with all applicable prevailing wage rate requirements pursuant to Labor Code §§1770 et seq.

The District reserves the right to reject any or all Bid Proposals and to waive any irregularities or informalities in any Bid Proposal received.
