Senate meeting since I no longer receive an Outlook invite for the Academic Senate meetings (apologies). A follow-up town hall will be scheduled on Friday, January 30th from 12p - 1p (Outlook Invite Forthcoming). Highlights: Construction for the Student Housing Complex will not occur the first two weeks of the semester and is scheduled to start Feb 9, 2026. A webpage will be created and frequently updated to keep everyone informed of construction plans and progress.

- **Progress on Amending California Code, Education Code - EDC § 76140:** I have been working closely with Assemblywoman's Hadwick office to amend Education Code - EDC § 76140 which would allow us to offer up to 200 students, from neighboring Oregon counties, non-resident tuition rates. This would be of huge benefit to our College in terms of enrollment. As you know, although the College is participating in Oregon Exchange and Western Undergraduate Exchange, we are maxed on the number of students allowed in these programs. - **Spring 2026 Enrollment Open: Women's Equity Empowerment Certificate Program:** The Spring 2026 cohorts begin February 17th, 18th, and 19th, 2026. The program is delivered online in a synchronous format via Zoom. The Women's Equity Empowerment Certificate Program helps women employees across colleges gain the tools and confidence to empower themselves to support the college's goals through self-advocacy, personal agency, and equity. - **DEIA Trainings via the Vision Resource Center:** The Vision Resource Center (VRC) can be accessed by all employees through mySiskiyous in the Professional Development section. Click on 'Online Training Videos - Vision Resource Center'. Completion and reflection of DEIA trainings may be applied towards employee evaluations in the DEIA section. Some VRC topics include: Cultivating Belonging through Refinement of Institutional Practices in Financial Aid (Intermediate), Challenging the Stigma of Poverty in Basic Needs Supports and Services (Entry-level), and Anti-Racist Curriculum: Implicit Bias and Cultural Competency.
