#### **CARES Act Grant Process**

 Funding formula created to award based on greatest need, as determined by set criteria per federal guidelines

- Application created in order to award grants to only eligible students, as identify by federal regulations as identified by Federal Department of Education, pursuant to the HEA Code Section 484.
- Application will also serve as documentation to demonstrate compliance
- All applications are verified to ensure student eligibility in addition to self-certification.
   This ensures all applicants meet the eligibility criteria of HEA Section 484.
- Applications reviewed by grant award workgroup. Decisions regarding grant amount based on need per funding formula.
- Approved Applications are submitted to the Financial Aid Office and awarded to student accounts.
- The Business Office sends out weekly Cares Grant Payments via BankMobile.
- The Financial Aid staff will assist students who do not have a BankMobile account.
- Students may contact the Financial Aid office to set up refund preference with BankMobile.

# College of the Siskiyous CARES Act Grant Application for Students

Through the Coronavirus Aid, Relief and Economic Security (CARES) Act, College of the Siskiyous is able to offer financial assistance to students in need. The purpose of the funds is to award emergency financial aid grants to students for specific expenses that are a direct result of the disruption of campus operations due to COVID-19.

College of the Siskiyous will be using an online application to assist us in determining eligible students to receive funding from the CARES Act funds allotted.

If you are a College of the Siskiyous student eligible for financial aid and/or eligible to complete a FAFSA and the COVID-19 pandemic has negatively impacted your personal financial situation, you can apply to receive a lump sum of up to \$2000.

### **Eligibility Requirements:**

Students are evaluated in a three-tier process – same application criteria but in three levels.

- Priority 1 Completed at least one class spring semester.
- Priority 2 No longer enrolled due to significant disruption of program on campus. First review will be July 1, 2020
- Priority 3 Withdrew before the end of spring semester. First review date will be August 1, 2020

College of the Siskiyous has your FAFSA on file or has determined you are eligible to complete a FAFSA

- You are currently enrolled in Spring 2020 classes
- You have completed a FAFSA for 2019-2020, or,
- You are eligible to complete a FAFSA for 2019-2020
- You have a valid Social Security Number
- You have registered with selective service (males only)
- You have a high school diploma, GED, or equivalent
- You are a citizen or eligible non-citizen
- You are not in default on a Title IV federal student loan or owe a refund on a Title IV federal student grant or loan overpayment

## You are not eligible to receive funds if you are a/an:

- International Student
- Undocumented Student
- Non-matriculated student
- Students enrolled in online-only degree programs (College of the Siskiyous does not have degree programs that are fully online)

#### **About the Fund**

- The maximum amount a College of the Siskiyous student can receive for Spring 2020 is \$2,000
- Awards will be distributed until CARES Act funds are exhausted
- This award is **not** a loan and does **not** have to be paid back
- Funding from the CARES Act Grant will not impact a student's financial aid package
- CARES Act grants cannot be used to cover and satisfy a student's outstanding
  account balance. The student may use their emergency financial aid grant for
  expenses related to the disruption of campus operations due to coronavirus
  including, hardships related to food, housing, course materials, technology,
  health care, loss of student employment and childcare.
