New Business I. Verto ISA	New Business  1. Verto ISA The program is similar to a travel abroad study program. Verto has CA students and they are looking for a CA school to partner with to offer their classes. Each student would be enrolled in 15-16 units which is equivalent to ½ FTS. A contract would be developed for Verto, similar to the one we currently have with FIELD. Verto claims it will provide all services to students—orientation, advising, financial aid, registration, etc. All of the courses are credit course and COS will have to do a substantive change if we move forward with the program. COS will likely have to develop some courses, but there are at least a couple that already exist. IT will need to be involved because students cannot access mySiskiyous from another country at this time.
