D. ACTION / DISCUSSION ITEMS

- 1. Review and approve "Before You Get Started" Proctorio checklist: Abbott moved to approve the student checklist; Blink seconded. Motion passed unanimously. Checklist will be placed on Student Proctorio guide, and in the Canvas Commons (COS). The group discussed the need for a fake test student that instructors could add to their course to test Proctorio/Turnitin settings. Fernandez to submit a HelpDesk request to IT to create a fake test student.
- 2. DL addendum for curriculum (first review): Fernandez presented the draft of the new DL addendum for feedback. The group made suggestions to increase clarity in Section 2 and Section 3. Fernandez to make changes and bring for final approval in April meeting.
- 3. Distance Learning Program Review (first review): Fernandez shared draft with the committee, gathered suggestions in Strategic Goal #1 to add "create a fully staffed Distance Learning Center"; keep Yreka VC tech support position. In Strategic Goal #2 to create CQIP for Instructional Designer/Accessibility Support position, create specific budget line items for distance learning training and professional development, fold in online teaching requirements in all future HR announcements, ensure faculty and students are fully supporting in proctoring needs online and in-person; add Nathan Rexford to contact people. No suggestions were offered for Strategic Goal #3. Fernandez to make changes and attach relevant data before submitting to Dr. Perlas.
