We also recommended 'mini-mesters' which were more structured (like ACE) and promoted through intentional marketing. Another recommendation was to reach out to students who dropped or, didn't seek the necessary support services. Also discussed were solid time blocks and how they will not work for all classes especially high unit and CTE. It was recommended that we add a section in the plan that pertains to retention and expansion of existing programs.
