Delete item 5, but move last sentence in item 5 to the last paragraph of item 3. Change item 6 to item 4.
  - Under C. Awarding Credit for Non-Collegiate Instruction, delete item 1 and item 2. Change item 3 to item 1 and add (AP 4235) to the end of the paragraph of item 1.
  - Under C. Awarding Credit for Non-Collegiate Instruction, change item 4 to item 2 and add (AP 4235) to the end of the paragraph of item 2. Change item 5 to item 3 and add (AP 4235) to the end of the paragraph of item 3. Change item 6 to item 4. Change item 7 to item 5. Change item 8 to item 6.

    - On 2<sup>nd</sup> page, 2<sup>nd</sup> paragraph will read, "Degree and certificate programs must have been approved by the Chancellor's Office."
    - On 2<sup>nd</sup> page, 3<sup>rd</sup> paragraph will read, "The courses of instruction are specified in the agreement; the outlines of record for such courses are approved by College of the Siskiyous Curriculum Committee as meeting Title 5 course standards; and the courses have been approved by the district Board of Trustees".
    - On 2<sup>nd</sup> page, 4<sup>th</sup> paragraph, delete the comma in the second line, beginning of 3<sup>rd</sup> line will read, "...are also applied." Capitalize the "c" in courses to begin a new sentence, and change "and students" to "so students".
