I. CQIP Requests – IPB Open Hearing Recap

Discussion ensued regarding hiring and when we will be notified of approval to hire. Perlas mentioned, in the best case scenario, we will know shortly after the August revise. Rexford mentioned the COLA and the related uncertainty. Discussion ensued regarding Athletics and reporting structure (requested CQIP was presented in the President's Open Hearing. Should be presented in the Instruction Open Hearing). Perlas to work closely with Roche to include applicable Athletic CQIPs in Instruction Open Hearing.

II. AP 4236 – AP Credit – Perlas

Van Alfen moved. V. Roberts 2nd.

Discussion ensued regarding Credit By Exam and the inclusion of AP credit. Credit by Exam is now converting to Credit for Prior Learning. Question regarding awarding of 6 units for AP English and Composition. Recommended that we define AP, post the matrix as well as the last paragraph on the College Placement page and direction to contact a counselor/advisor. Recommend to change 'Internet Web site' website.

III. COVID-19

Discussion ensued regarding Emergency Blanket DE Addendum application, planning for Summer and Fall, safety 'before, during and after' protocols, Governor's directive, limitations to class sizes and social distancing. Klever has requested a policy which mandates groups of 10 or less. Gale mentioned that the CDPH states that all non-essential gatherings should be canceled. For our essential programs, this does not pertain. Also need to think about reopening Library and ASC. Korkowski mentions that CVC-OEI has stated that many colleges have gone completely online for Fall. If there are no Athletic Competitions in Fall, we will lose up to 300 students so we should consider placing many courses online. Recommended to notify students if the courses 'may be' offered synchronously, online/remote.
