IV. Student Equity Update

Target students are being identified through high school outreach, SOARS, and Siskiyou Promise applications. Lauren will be leaving at the end of May and her replacement can begin contact during the summer. It is still being determined how funding is prioritized - EOPS, FA, then Equity (?) Melissa feels that whatever best serves each student will be the method we'll use.

V. Food Pantry and Health Clinic Update

- It proved too costly to move the Health Clinic from the Lodges. Additionally, because of the lack of health fee revenue there will not be the option to add an additional clinic day. There is a plan to make the office available to other Services Organizations when the clinic is not open. There is serious interest from Domestic Violence and the Department of Rehab.
- Logistics for Food Pantry are still being discussed.
