# The Child Development and Early Education Program at College of the Siskiyous

This is a general introduction to the ECE Program at COS and a compilation of supporting documents. This is shared context which helps us maintain our ECE Community and serve children and families.

### Our Program

The ECE--Child Development and Early Education Program at College was established in 1965 and has grown to offer curriculum aligned with 109 other California Community Colleges. In two years you can complete an A.A. Degree in Child Development, a Transfer Degree to any California State University or you can articulate, as a junior, to Southern Oregon University's online Early Childhood Development Program.

Our classes lead directly to all levels of the Child Development Permits issued by the California Commission on Teacher Credentialing and satisfy Title 22 requirements for work in early education.

Our practicum site at Discovery Child Development Center a collaboration with Shasta Head Start--is the only program in Siskiyou County Accredited by the National Association for the Education of Young Children. Through our work with the California Early Childhood Mentor Teacher Program we offer additional practicum sites throughout Siskiyou County.

Students often work in early education programs while completing classes for their A.S. degree, Permits, or transfer requirements. Graduates of our program are working at Head Start, California State Preschools and Independent Programs. Many transfer to California State Universities or Southern Oregon University's online ECD Program. Others choose to complete their B.A. degrees in elementary or primary education

- The Early Childhood Education major requirements below.
- The California State University General Education Breadth (CSUGE) **or** the Intersegmental General Education Transfer Curriculum (IGETC) requirements. \*\*Please note: Area 6-Languages Other Than English on the IGETC is **NOT** required for the AS-T.
- Any needed transferable electives to reach a total of 60 CSU transferable units.
- All major courses and any courses noted on the CSUGE or IGETC check sheets must be completed with a C or better.
- Double counting courses in GE and the major is permissible.

# Course of Study in Early Childhood Education - College of the Siskiyous

## Articulated with the Early Childhood Development Program at Southern Oregon University

Origination: Fall Term 2017 - Remains in effect until updated or terminated by COS or SOU

### **About the Program**

The Course of Study in Early Childhood Education has been developed with the cooperation and support of Southern Oregon University (SOU). The Course of Study is fully articulated with SOU's Early Childhood Development program and allows students to transfer directly as juniors and to become admitted into the School of Education at Southern Oregon University with no loss of credits to pursue a bachelor's degree. The program offers an excellent balance of Early Childhood coursework and general education courses that support advanced study in the field of Education and the Early Childhood Development.

Students should contact the SOU School of Education early in the first year of their Early Childhood Education program to be advised about additional requirements and procedures for admission to the school or program. Students should be aware of the admission requirements at SOU, including the minimum GPA requirement of 2.75 for all ECD/ECE coursework.

Students should be aware that if they transfer before completing this program, their courses will be evaluated individually toward the general education requirements in effect at SOU.

### **Entry Requirements**

Students who have not satisfied the Math and English general education requirements must take the college placement test to determine skill level and readiness indicated by test scores. As part of their training program, students must begin with the courses within their skill levels as determined by placement test scores. In addition, students may be required to enroll in classes that would increase their employability and success.

### **Advanced Standing**

Coursework from accredited colleges and universities will be accepted in accordance with college policies and the approval of the Director of the School of Education. To ensure coursework is current, program course credits over 5 years old must be reviewed and approved by the appropriate department head before being accepted toward course requirements.

### **Graduation Requirements**

Students must complete a minimum of 81 semester credits of lower division collegiate courses with a minimum grade of "C" or better. California students may satisfy SOU General Education requirements by completing any one of the three GE options: SOUGE, CSUGE, or IGETC. These options are described on page three of this agreement. Completion of CSUGE or IGETC must be certified by COS Counseling Services. See COS advisor for details. Please note that following the SOUGE and program requirements yield less than 81 units from COS. Additional ECE elective courses may be taken and the remainder of any additional lower division units can be completed at SOU.

Consultation with an SOU Academic Advisor is highly recommended should you decide to follow the SOUGE path.

### General Education Requirements for the ECD Program:

There are three possible options for COS students to satisfy General Education Requirements:

### 1. Complete the COS-SOU General Education requirements:

This option requires a minimum of 32 semester credits (33-38 credits is typical). Students must complete the entire SOUGE pattern, *including* these specific courses to satisfy ECD prerequisites:

Quantitative Reasoning - Must include MATH 1050\* (formerly MATH 2)

**Humanities** - One English course (ENGL 2036 satisfies the Humanities requirement and is also required for the ECD... *formerly ENGL* 36)

**Social Science** - Must include one Geography and one History course

**Science** - One Physical Science and one Life Science course from the list. Both courses must have labs.

### 2. Complete the COS-CSUGE requirements:

This option requires a minimum of 39 semester credits (42 credits is typical). Students must complete the entire CSUGE pattern, *including* these specific courses to satisfy ECD prerequisites:

**Area B4** - Must include MATH 1050\* (formerly MATH 2)

**Area C2** - Must include one English course (ENGL 2036 satisfies an Area C requirement and is also required for the ECD... *formerly ENGL 36*)

**Area D** - Must include one Geography and one History course

This option requires a minimum of 33 semester credits (36 credits is typical). Students must complete the entire IGETC pattern, *including* these specific courses to satisfy ECD prerequisites:

**Area 3 - Must include one English course (ENGL 2036 satisfies an Area 3 requirement and is also required for the ECD...** *formerly ENGL 36*)

**Area 4** - Must include one Geography and one History course

### Where am I going and how do I get there?

We are so glad you asked! We hope that this guide will help you define your professional and educational goals. And we are ready to help you achieve them.

Students enter our program for a variety of reasons. Some are experienced early educators who use our classes for professional development or personal growth. Others are new to early education and have found that they need these classes to work with young children. Still others are on their way to a Bachelor's or Master's Program and leadership in our field and are seeking their A.S. Transfer Degree or capstone classes to qualify for advances Child Development Permit. And... others are just curious and interested. We welcome you all.

Our classes follow a Yearly Rotation. Our classes go in numerical order. If you take them, along with required General Education Classes, in order, attending full time an A.A. or A.S. Transfer can be completed in 2 academic years. Although our classes are in order, there are seldom prerequisites, so...if a student cannot attend College of the Siskiyous full time the ECE Program and your Counselors or Advisors will scaffold your journey for as long as it takes!

# **ECE Classes by Semester** Classes required for degrees are in BLUE Fall Classes

**ECE 1001 Introduction to ECE Principles, Practices and Standards:** This is the introductory class. It is a CORE class required for the A.S./A.S.-T/Permits/Title 22 requirements. It is offered every fall face-to-face and videoconferenced. Very seldom it is offered in the summer, online.

**ECE 1002 Child Development:** This is a CORE class required for the A.S./A.S.-T/Permits/Title 22 requirements. This class also satisfies the G.E. Social Sciences requirement. It is offered every fall face-to-face and videoconferenced. It is also often offered online, typically in the spring.

**ECE 1003 Child, Family and Community:** This is a CORE class required for the A.S./A.S.-T/Child Development Permits/Title 22 requirements. This class also satisfies the G.E. Social Sciences requirement. It is offered every fall face-to-face and videoconferenced. It is not offered online.

ECE 2000 Observing and Assessing--Desired Results and Developmentally Appropriate Environments: This class is required for the A.S./A.S.-T/Advanced Permits. It is an advanced class—students should complete, or be enrolled in, the majority of their CORE classes before enrolling in this class. It is offered every fall face-to-face and videoconferenced. It is not offered online.

**ECE 2002 Child Nutrition Health and Safety:** This class is required for the A.S./A.S.-T/Advanced Permits. It is an advanced class—students should complete, or be enrolled in, the majority of their CORE classes before enrolling in this class. It is offered every fall face-to-face and videoconferenced. It is not offered online.

**ECE 1999 Human Development:** This class is NOT required for the A.S./A.S.-T/Child Development Permits. However, it does satisfy a CORE class requirement (can replace ECE 1002) for the Child Development Permit. This class also satisfies the G.E. Social Sciences requirement. It is offered most falls online and every spring face-to-face and videoconferenced.

**ECE 2003 Serving Children and Families with Special Needs:** This class is NOT required for the A.S./A.S.-T/satisfies Master Teacher Permit specialization. It is offered in the fall online.

**ECE 2527 Supervision of Adult Staff in Early Education:** This class is NOT required for the A.S./A.S.-T/required for Site Supervisor or Program Director Permits/required for Mentor Teachers. It is offered in the fall online.

**ECE 0958 ECE Lab:** This is a one or two unit lab-only class. This class is NOT required for the A.A./A.S.-T/required as one extra lab unit for Southern Oregon University Articulation. It is offered most semesters.

### Spring Classes

**ECE 1500 Introduction to Curriculum:** This is a CORE class required for the A.S./A.S.-T/Child Development Permits/Title 22 requirements. It is offered every fall face-to-face and videoconferenced. It is sometimes offered online, but is not regularly scheduled as online.

**ECE 1501 Positive Child Guidance:** This class is NOT required for the A.S./A.S.-T/ applies to Master Teacher Permit Specializations. It is offered in the spring online.

**ECE 1502 Serving Children and Families in a Diverse Society:** This is a class required for the A.S./A.S.-T/ applies to Master Teacher Permit Specializations. This class also satisfies the G.E. Diversity requirement. It is offered every fall face-to-face and videoconferenced. It is sometimes offered online, but is not regularly scheduled as online.

ECE 1999 Human Development: See Above

**ECE 2500 Family Relationships and Parenting:** This class is NOT required for the A.S./A.S.-T/ applies to Master Teacher Permit Specializations. However, it does satisfy a CORE class requirement (can replace ECE 1003) for the Child Development Permit. This class also satisfies the G.E. Diversity requirement. It is offered in the spring online.

**ECE 2501 Administration**: This class is NOT required for the A.S./A.S.-T/ required for Site Supervisor or Program Director Permits/required for Mentor Teachers. It is offered in the spring online.

**ECE 2502 Practicum:** This is a class required for the A.S./A.S.-T/ Child Development Permits. This is a lecture/Lab class requiring 6 per week hours of work in an approved early education program. The California State Department of Education and Community Care Licensing Department of Social Services requires that students satisfy immunization requirements. ## Community Care Licensing Update IMMUNIZATION REQUIREMENTS FOR PRACTICUM STUDENTS

The law: SB792

Requires immunizations of all employees and volunteers in a child care setting who provide "care and supervision" of children. These immunizations include influenza, pertussis, and measles. The influenza vaccine is the only one that can be a choice and this requires a signed document from the employee/volunteer.

The following updates were obtained at the Fall CCCECE meeting in Sacramento. The Directors of Community Care Licensing in attendance included: Shanice Orem, Cecelia Asher-Falk, and Maria Mayorga, Policy Manager.

### What's happened:

The initial interpretation by CCL on "care and supervision" was that anyone coming in contact with children needed to be immunized. As a result, many programs have quit having guest speakers, field trips, parent visits, and even doing tours for prospective parents. In a college setting, this meant even if students were just observing they needed to be immunized.

#### What's changed:

CCL has learned a lot in the past year and came to the table with more clarity based on a very frustrating 2016/17. They acknowledge that the initial messaging was not clear as could be. They have had their legal department involved and have encouraged questions. The common scenario that was heard in the beginning was that if a parent enters the classroom and sits down to read a book with their child that is fine. The moment another child comes over to hear the story; the parent would need to be immunized. This is no longer the case.

#### Here are some updates:

- In the scenario above, the parent does not need to be immunized to read a book to several children. However, if the same parent sees an altercation across the room and decides to intervene, then they are providing "care and supervision" and would need to be immunized.
- If Grandma comes into the room and volunteers for the day she needs to be immunized.
- All parents on Field Trips need to be immunized they are there to provide care and supervision.
- Anyone that helps with toileting needs to be immunized.
- Medical, Dental, Speech, or other professionals do not need to be immunized.
- Guest speakers in the classroom who are there to present do not need to be immunized.
- College students who are observing only do not need to be immunized.
- IMZ records do not need to be kept on the person. They need to be accessible to the analyst if requested. This can be at the site or at a central site.
- CCL recognizes the inconsistency among analysts and are working on a solution to this. In the
  meantime, if a program gets cited for something they feel is not a violation, it needs to be reported.
   CCL is hoping that the appeal process will be used more often almost all appeals submitted were
  overturned last year. More communication on issues will help analysts be more accountable and CCL
  understand what is happening in the field.

- It is critical to remember that CCL regulations are *minimal*. They are not Public Health standards.
- To meet CCL standards on immunizations a person needs the shots <u>1 time</u>. This is only <u>one</u> MMR (Public Health says 2), and <u>one</u> Pertussis they do not need to be up-to-date, just able to show proof that they have been done <u>at some point</u>. TB testing is required to be once only (for licensing). Most Centers and organizations set a higher standard that TB kept current at every 2 years. Remember: these are minimal licensing regulations, not best practices but if someone meets these minimal standards they are in compliance with the new law.
- The Pertussis titer is also included in the Tdap Panel along with Tetanus and Diphtheria.
- The MMR Titer is a blood test that checks if you are immune to Measles, Mumps and Rubella.

### From Title 22, Section #101152, C-3, Subsection A-H

- (3) "Care and Supervision" means any one or more of the following activities provided by a person or child care center to meet the needs of children in care:
- (A) Assistance in diapering, toileting, dressing, grooming, bathing and other personal hygiene.
- (B) Assistance with taking medications as specified in Sections 101226(e)(3) and (e)(4).
- (C) Storing and/or distribution of medications as specified in Section 101226(e).
- (D) Arrangement of and assistance with medical and dental care.
- (E) Maintenance of rules for the protection of children.
- (F) Supervision of children's schedules and activities for the protection of children.
- (G) Monitoring food intake or special diets.
- (H) Providing basic services as defined in Section 101152b.(1)

# Legal, Ethical, and Philosophical Standards for work in Early Education Programs

### **Legal Standards**

As in any field regulated through the state and federal government for the common good, early education programs require that employees meet legal standards for employment. In addition to the educational requirements for work in early education, legal requirements include, but are not limited to

- Live Scan fingerprint clearance
- Department of Justice clearance
- Immunization Requirements
- Mandated Reporting Status
- Permit Qualifications through the Commission on Teacher Credentialing Title 5
- Program Licensing Requirements through the Department of Social Services Community Care Licensing
   Title 22 Division 12 Chapter 1 Article 3 Section 101170 forward

#### **Prior Convictions**

Sometimes students with a criminal conviction in their past enter into ECE@COS. We make every effort to clarify the effect that these circumstances may have on their career path immediately, both through this program guide and in our course work. There is a process, through which individuals may appeal to the State of California Health and Human Service Agency and the DOJ to attempt to remove convictions from their record for the purpose of employment. It is complicated and demanding. Our program may provide some guidance in beginning this process but we are, in no way, responsible for providing legal or personal advice.

Sometimes a student is unaware of the impact that their particular crime will have or they believe that they will be able to avoid notice. Since we do not fingerprint, or require the DOJ Clearance, in order to take classes at COS, a student may not suffer the consequences of a prior conviction of a crime specified in the Title 22 sections noted above until they have completed many classes. However, Legal Standards met before employment in early education programs will prevent a student who has, deliberately or mistakenly, believed they were exempt from the law, from working in the field.

#### **Ethical Standards**

As in any field serving the common good, early education programs follow a code of moral and ethical conduct. Please see The National Association for the Education of Young Children's Core Values from The Code of Ethical Conduct below:

#### **Core Values**

Standards of ethical behavior in early childhood care and education are based on commitment to the following core values that are deeply rooted in the history of the field of early childhood care and education. We have made a commitment to

- •Appreciate childhood as a unique and valuable stage of the human life cycle
- •Base our work on knowledge of how children develop and learn
- •Appreciate and support the bond between the child and family
- •Recognize that children are best understood and supported in the context of family, culture,\* community, and society
- •Respect the dignity, worth, and uniqueness of each individual (child, family member, and colleague)

- •Respect diversity in children, families, and colleagues
- •Recognize that children and adults achieve their full potential in the context of relationships that are based on trust and respect
- \* The term *culture* includes ethnicity, racial identity, economic
