- 1. Spaces are \$30.00 per 10' x 10' space. All booth spaces will be outside rain or shine.
- 2. Banned from selling:
  - Activities: Vendors are prohibited from engaging in any activity that involves body puncturing, including but not limited to piercing of ears, noses, tongues, or any other body part, tattooing or any similar act that breaks the skin in any fashion.
  - Items: Do not sell or attempt to sell, market, advertise, give away, or have in your possession: illegal drugs or drug paraphernalia (this includes glass pipes, vapes, or other such items), cannabis, medicines, nutritional supplements, alcohol, polystyrene foam disposable food service ware including cups and food containers, candy, stolen property, poppers, fireworks, firearms, weapons, switchblades, fixed blades of 2 ½ inches or more, and/or any other illegal items.
- 3. Code of Conduct: Physical or verbal threats or abuse, obscene, libelous or slanderous conduct, disruptive behavior, willful disobedience, profanity, vulgarity, open and persistent defiance of authority, or persistent abuse of College or District personnel will not be tolerated and may result in immediate and permanent expulsion from the Flea Market.
- 4. Seller's Permit: Vendors are responsible for observing all California State Board of Equalization rules and regulations for selling goods and services. Most vendors need a Seller's Permit if they sell new or handcrafted items or sell used personal items more than two times in a 12-month period. See <a href="www.cdtfa.ca.gov">www.cdtfa.ca.gov</a> for more information.
- 5. If you are selling or having samples of any food/drink products, you must contact the Siskiyou County Environmental Health Department at (530) 841-2100 or visit <a href="www.co.siskiyou.ca.us">www.co.siskiyou.ca.us</a>. A health permit may be required.
- 6. "Pack it In, Pack it Out", take any large trash items, boxes, packaging, and unsold items with you at the end of your selling day.
- 7. No tables and chairs will be provided.
- 8. Vendors are asked to check in with the market managers when arriving so they may be shown to their space.
- 9. Setup/Teardown Setup is between 7:00 am 8:45 am on Saturday, August 23 and teardown is between 3:00 5:00 pm. All booths need to be set up and ready for sales no later than 8:45 am.
- 10. Due to the unpredictable weather conditions in Siskiyou County, we ask that you take into consideration the weather forecast and be prepared for any conditions that may arise. Vendors are responsible for safely securing canopies, tents, umbrellas, etc. and merchandise in the event of wind or natural disaster.
- 11. At the event, each vendor is responsible for the sale and security of their rented space. They are also responsible for cleaning their area at the close of the event and take any unsold items home with them.
- 12. **We do not offer/provide electricity**. If you need electricity, you need to provide your own battery-operated devices.

- 13. The COS Public Relations Office will advertise the event with:

  - Press releases and ads in Klamath Falls & Medford, OR; Redding, CA, newspapers
  - Flyers will be placed on campus, and sent to libraries, chambers, local motels, and restaurants.
