- Report out from Mandy on the GP DSPS webinar Mandy provided an overview of a webinar she attended "GP: Strengthening & Supporting Teaching and Learning for Students with Disabilities". Highlights included bringing awareness and support for DSPS to every place on campus, some students feeling "outed" by being part of the program how can we change that?, Universal Design and being accessible assists everyone, having someone in each department/area that can help is beneficial, and that it's important to help the campus know how to assist these students. She also said that it was suggested to ask staff/faculty to share if they have a disability and have them serve as allies.

 - Recruitment/Outreach looking at recruitment software; money was spent on Banner recruitment and we're waiting on upgrade to Banner 9 so we can use it; working on recruitment packet information and how best to communicate with prospective students; "robo apps" are an issue with CCC Apply and are creating many fake applications which need to be gone through to verify.
 - o Enrollment/Enrollment Management leaders -no report. Next meeting is on 4/13
 - Career Exploration leaders the benefits of You Science was highlighted; aptitude versus self-reported interest is resulting in more options for females and reduced influence of socialized norms.

- Onboarding/Orientation leaders online SOAR is being used exclusively this semester;
 collaboration with other focus group areas (welcome packet, etc)
- Are our Focus Groups still what/as we need? Focus groups report that they have not been meeting as needed.
- Next areas of focus for Pillar 2? What are our desired outcomes?
 - Enrollment/Enrollment Management does that belong in our pillar? There is a committee to work on these efforts. Maybe a report out on that committee's meetings would be sufficient.
