Updated COVID Safety Protocols!

After review of feedback and consultation with constituency groups, the College's COVID safety protocols have been updated as follows:

- Face coverings are not required for students, faculty, and staff who are fully vaccinated. By entering
 a building on a College of the Siskiyous campus not wearing a mask, you are self-attesting that you
 are fully vaccinated.
- Face coverings are required for those who are not fully vaccinated.
- Social/physical distancing requirements have been removed, with the exception of major outbreaks.
- Unvaccinated, or partially vaccinated, students and employees need to wear face coverings indoors and when in vehicles with more than one person.
- N95 masks will be available for those that would like one upon request.
- When necessary, employees may get tested for COVID during work hours.
- The HealthScan app will continue to be required for all employees as well as Athletic personnel and students.

College of the Siskiyous - Incident Command Center

On June 30, College of the Siskiyous became an Incident Command Center for hundreds of firefighters who were working tirelessly to protect our communities from the Lava and Tennant wildfires. Many of our employees were forced to evacuate their homes not knowing if they will have a home when they returned.



As a result of the strategic efforts implemented by the Incident Management Teams and numerous fire personnel, many homes were saved. Words cannot express how grateful we are to the Forest Service, CalFire and all of the Fire Company personnel who assisted in these efforts.

Although the Lava and Tennant fires are largely contained, we are not free from harm. The recent heat waves and critically dry fuels have sparked a number of fires including Southern Oregon's Bootleg Fire which is being referred to as the mega fire. It is more important now than ever to be prepared. The Red Cross has developed a wild fire checklist which can be accessed on the following page or via this link:

Wild Fire Safety Checklist

More and more people are making their homes in woodland settings, rural areas or remote mountain sites. There, residents enjoy the beauty of the environment but face the very real danger of wild fires. Wild fires often begin unnoticed. They spread quickly, igniting brush, trees and homes. In a wild fire, every second counts!

Supplies to take with you if you need to evacuate:

• Water—one gallon per person, per day (3-day supply) • Food—non-perishable, easy-to-prepare items (3-day supply) • Flashlight • Battery-powered or hand-erank radio (NOAA Weather Radio, if possible) • Extra batteries • First aid kit • Medications (7-day supply) and medical items • Multi-purpose tool • Sanitation and personal hygiene items • Copies of personal documents (medication list and pertinent medical information, deed/lease to home, birth certificates, insurance policies) • Cell phone with chargers • Family and emergency contact information • Extra cash • Emergency blanket • Map(s) of the area • Other essential items that could not be replaced if they were destroyed

What should I do to prepare ahead of time?



- □ Learn about wild fire risks in your area
- ☐ Talk with members of your household about wild fires—how to prevent them and what to do if one occurs.
- □ Post emergency phone numbers by every phone in your home.
- Make sure driveway entrances and your house number or address are clearly
- ☐ Identify and maintain an adequate water source outside your home, such as a small pond, cistern, well or swimming pool.
- □ Set aside household items that can be used as fire tools: a rake, ax, hand saw or chain saw, bucket and shovel. You may need to fight small fires before emergency responders arrive.
- \square Select building materials and plants that
- ☐ Regularly clean roofs and gutters.

Plan ahead and stay as safe as possible during a wild fire.

- Plan and practice two ways out of your neighborhood in case your primary route is blocked.
- ☐ Select a place for family members to meet outside your neighborhood in case you cannot get home or need to evacuate.
- ☐ Identify someone who is out of the area to contact if local phone lines are not working.

What should I do if there are reports of wild fires in my area?



- ☐ Be ready to leave at a moment's notice.
- Listen to local radio and television stations for updated emergency information.
- Always back your car into the garage or park it in an open space facing the direction of escape.
- ☐ Confine pets to one room so that you can find them if you need to evacuate quickly
- Arrange for temporary housing at a friend or relative's home outside the threatened area.

Limit exposure to smoke and dust.

- ☐ Listen and watch for air quality reports and health warnings about smoke.
- Keep indoor air clean by closing windows and doors to prevent outside smoke from getting in.
- ☐ Use the recycle or re-circulate mode on the air conditioner in your home or car. If you do not have air conditioning and it is too hot to stay inside with closed windows, seek shelter elsewhere.
- □ When smoke levels are high, do not use anything that burns and adds to indoor air pollution, such as candles, fireplaces and gas stoves. Do not vacuum because it stirs up particles that are already inside your home.
- ☐ If you have asthma or another lung disease, follow your health care provider's advice and seek medical care if your symptoms worsen.

Returning home after a wild fire ...



- ☐ Do not enter your home until fire officials say it is safe.
- Use caution when entering burned areas as hazards may still exist, including hot spots, which can flare up without warning.
- ☐ Avoid damaged or fallen power lines, poles and downed wires.
- Watch for ash pits and mark them for safety—warn family and neighbors to keep clear of the pits also.
- Watch animals closely and keep them under your direct control. Hidden embers and hot spots could burn your pets' paws or hooves.
- □ Follow public health guidance on safe cleanup of fire ash and safe use of
- ☐ Wet debris down to minimize breathing dust particles.
- Wear leather gloves and heavy soled shoes to protect hands and feet.
- Cleaning products, paint, batteries and damaged fuel containers need to be disposed of properly to avoid risk.

Ensure your food and water are safe.

- □ Discard any food that has been exposed to heat, smoke or soot.
- Do NOT ever use water that you think may be contaminated to wash dishes, brush teeth, prepare food, wash hands, make ice or make baby formula.

Let Your Family Know You're Safe

If your community has experienced a wild fire, or any disaster, register on the American Red Cross Safe and Well Web site available through **RedCross.org** to let your family and friends know about your welfare. If you don't have Internet access, call **1-866-GET-INFO** to register yourself and your family.



Administrative Services

It has been a busy summer for Administrative Services and Human Resources so far, but very productive as we enter the month of July. Thank you to everyone for supporting the campus during the LAVA fire evacuation, campus closure, and the 1,500 plus fire personnel who joined us on June 30. Amazing job!! We hope that everyone continues to remain safe and healthy!

Facilities: Update on projects currently in progress.

- The new Soccer Field Construction Project will be completed on August 1 and will be ready for our fall semester sports season. Irrigation on the new field began July 16 and will be followed by the installation of 88,000 square feet of new sod.
- The new Fire Tower Prop Project will begin on July 19. The west side fire tower training area will be off limits to vehicle and foot traffic until construction is complete.
- All of the Maintenance staff have worked extra hard the past three weeks to accommodate the 1,500 + Lava Fire Camp personnel and we want our crew in maintenance and custodial to know we appreciate all their tremendous work and time spent in helping the fire personnel feel welcome at our campus. Excellent job!

Fiscal Services: With the 2020-21 fiscal year end just past, please do a final review of your department activity and make any necessary changes before July 31.

- Check your budgets and expenditures. If you have any final budget or expenditure changes, please submit the approved form(s) to the Business Office. If you have any questions, please e-mail Desiree in the Business Office.
- Review any outstanding purchase orders and submit any invoices as soon as possible. If you need to cancel a purchase order or if you have any questions, please e-mail Courtney in the Business Office.

Some reminders:

- During the summer months while the campus is on a four-day work week, all approved payment vouchers must be submitted to the Business Office by 5 p.m. on Tuesday in order for them to be paid that week. With the shortened work week, the weekly accounts payable check run will be processed starting Wednesday morning in order to make payment by Thursday.
- Employees who would like to receive their paycheck via direct deposit can access the Direct Deposit authorization form through mySiskiyous/Employee/Pay. Once the form is completed submit to Human Resources.

Food Services: As summer conference season is coming to an end, the staff in food services are working with Human Resources staff to fill vacant positions and get ready for the start of the fall semester. Finding applicants is a challenge, with so many jobs available in the hospitality industry.

Human Resources: HR continues to recruit on the average 12 positions a month with several of these vacancies being filled within the next 30 days. HR will be meeting with representatives from the Faculty Association, CSEA, ASM and CVT to share a presentation and information on what has impacted the new medical coverage rates which go into effect on October 1. At the start of the Fall Semester we will be reviving the HWB Committee which will include a membership from constituent groups across the

campus in an effort to do a full review of the plan designs currently offered by the District for medical, dental, and vision coverage.

Technology Services: The Department successfully executed a re-architect of the data network that included the upgrade of the College's virtual private network (VPN) from Cisco AnyConnect to Palo Alto Global Protect.

An upgrade to the HappyFox ticketing system was also successfully completed. This upgrade includes an improved user interface and a simplified ticket entering process that will support the department's efforts to implement Information Technology Service Management (ITSM).

Residence Life & Housing: Student lodging has received an application for every bed space available in the fall of 2021. A room waiting list has started because some of the lodging applicants may change their minds about attending our college. Lodge staff accept waiting list applications and refer students to off-campus housing options. Our staff has received feedback that local rental options are unavailable. Student housing staff continue to look for ways to help students find safe and secure housing.

Associated Student Board: The District's student government is looking for new members to join the student leadership team for the fall. We have a little help... ASB Senators in the spring sent invitations to all enrolled students inviting them to join the National Society of Leadership and Success. Working with NSLS staff will allow COS students to develop leadership skills and network with other leaders from around the country. ASB Senators anticipate some of the NSLS participants will join the ASB team to use their skills learned from the NSLS program.


