



**Proposed COVID Requirement:** In consultation with our constituent leaders, the College is proposing the following COVID requirement:

- Students must show proof of vaccination or commence weekly COVID testing by November 15, 2021.
- Employees must show proof of vaccination or commence weekly COVID testing by January 3, 2022.

Administrative Procedures (AP) and Board Policies (BP) are currently being revised and developed to reflect this new requirement. The revised and new APs and BPs will be vetted through the participatory governance process. This new requirement is not official until it is Board Approved. Once approved, the requirement will be shared widely via COS Connect, website and social media.

**Updated COVID Prevention Plan:** Throughout the Pandemic, the College's COVID-19 protocols have been in alignment with guidance set forth from Siskiyou County Public Health, California Department of Public Health, Center for Disease Control, and CalOSHA. There have been some recent changes in guidance and it is now reflected in the College's September 2021 COVID Prevention Plan. The Plan contains useful information regarding on-campus check-in procedures, mask and campus closure guidelines, guidance on isolation and quarantine, proposed COVID requirement and self-care during

### **Administrative Services**

#### **Facilities:**

The Theater Project has new life and this is a wonderful new opportunity for us to rehabilitate two, fifty year old buildings on campus. The District has entered into an agreement with Alma Strategies which has been approved by the Board of Trustees to help the District re-scope the project for presentation to the California Community Colleges Chancellor's Office and the Department of Finance.

The sod in the soccer field is growing tall and thick. The scoreboard is in DSA approval process and many other parts of the project still remain in the design phase. Clearing and clean up continue to be the maintenance crew's main focus as this has been a collaborative project with outside vendors. Fire tower prop project structure will be delivered on September 28th. This project is still on schedule to be completed in late December.

The Facility Master Plan Final Draft is going through the governance process this month with the Final Draft being presented to the Board on September 21<sup>st</sup> then taken back for action at the October Board meeting.

#### **Fiscal Services:**

The 2021-22 Final Budget was approved by the Board of Trustees on September 14<sup>th</sup>. The Final budget will be posted in Banner shortly.

- All Purchase Requests, regardless of amount, must be approved by Darlene Melby before submitting to the Business Office.
- If you need to use a **Payment Voucher**, any invoices over \$250 must have <u>pre-approval</u> from Darlene.
- For Cal-Card/District Credit Card purchases, any purchases over \$250 must have pre-approval from Darlene (please attach any email pre-approvals to your Cal-Card Statement).
   All Cal-Card Statements must be signed by your immediate supervisor and Darlene.
- All Travel Requests must be pre-approved by Darlene.

#### **Food Services:**

The National Outdoor Leadership School (NOLS) arrived on campus in early September. The students are attending a four-week course to earn a certification in Wilderness Emergency Medicine. A second fall course will begin in November. NOLS rents facilities at the COS campus for this program and they hold five of these courses each year. Food Services staff support their dietary needs, which are often different from our current residents and staff, but the partnership has been very strong and positive for several years.

#### **Human Resources (HR):**

Human Resources (HR) welcomes Amy Howell to Administrative Services. Amy will be assuming the role of Executive Administrative Assistant I with her work station located in the Human Resource Department. Please stop by and say hello to Amy if you are in the area.

#### **Residence Life and Housing:**

The State Legislature has passed Senate Bill/Assembly Bill 169, which commits funding to address college student housing challenges. This is an exciting development for College of the Siskiyous and the District will be pursuing a grant in order to seek funding for additional student housing. Fall 2021 occupancy remains high and Lodge staff are continuing to focus on helping students stay up to date on payments for tuition and fees and retention of students as the semester gets into full swing.

#### **Technology Services:**

As part of our continuing efforts to keep the College's infrastructure current, the department will be upgrading its virtualized server environment as well as the Exchange email system before the end of the calendar year.

The department has launched the Enterprise Application Steering Committee. They have responsibility for software applications that support the College's business processes such as Banner and Degree Works. This committee has produced a shared production calendar that will be used to plan regular maintenance and upgrades to enterprise applications.

The department is currently finalizing the Technology Master Plan for 2021-2025. This plan will be presented to several governing bodies for review and input. It is expected that it will be published at the end of October or beginning of November.

# **Student Services**

The fall 2021 semester has begun and our students have returned to campus. The lodges are full, classes have begun, and staff and faculty are busy helping students to meet their goals. We are elated to be back on campus and see our students on a daily basis.

On September 1, a COVID Vaccine Clinic occurred on campus and was co-sponsored by College of the Siskiyous and Siskiyou County Public Health. The event was also open to the public. During the event, forty-one individuals received their COVID shot. On September 29, the Vaccine Clinic will return to allow individuals to receive their second shot. Those COS students or employees that received their COVID shot received a "thank you" appreciation gift card to the COS Bookstore or Café. Staff and students that had previously been vaccinated were also eligible to receive the "thank you" appreciation gift card. Our gratitude goes out to Siskiyou County Public Health, volunteers, COS employees, and those who chose to get vaccinated. We will continue to explore other opportunities to offer more clinics.

Work continues on researching options to purchase a "lactation pod." The College is required to provide a space that is private and safe for breastfeeding mothers. This can include students, employees, or anyone visiting the campus. This project and its completion are much needed to be compliant with the law and help provide a private space. Options for funding are being identified and staff are working hard with those that have a vested interest to make this happen.

Finally, a thank you to the Student Services staff and faculty for their hard work, dedication, and continuous support of our students. I am continuously amazed by what you all do and the way you carry yourselves in your efforts to serve students. The Student Services Staff ROCKS!!!

#### **Basecamp HQ:**

Basecamp has been very busy with the onboarding of new Eagle Ambassadors and preparing for a full schedule of events to take place during the fall semester. Coming up is the Eagle Student Resource Fair scheduled for Wednesday, September 22. We are excited to welcome our community partners and local employers to the campus so they can provide information on valuable resources and job opportunities to our students.

Now that our new Eagle Ambassadors are on-boarded, we are excited to launch a new program. The *Ambassadors for Multi-Purpose Program* will allow faculty, staff, and community members to request the assistance of our ambassadors for community events, campus activities, or even general office tasks that require help. More details will be made available in the coming weeks!

#### **Student Access Services (SAS):**

This month Student Access Services, SAS (formerly DSPS) is giving special recognition to Grace Root, who has overcome various barriers and is successfully transferring to a university after this semester. Grace has been awarded a Certificate of Achievement and had these words to share with us.

"Thank you to all the professors and students at COS who have helped accommodate me throughout the last two years. Also, thanks to the SAS office for helping provide my needs."

Speaking of overcoming barriers, SAS would like to share more information about our Peer Mentoring program. SAS is offering Peer Mentoring for SAS students in need of more intensive additional support for their classroom success. In order to be eligible for paid services as a student worker, the peer mentor must complete an application through Human Resources as a Student Worker, and must be enrolled for at least six units of classes. Eligible students will complete an orientation/training and receive a peer mentoring handbook. We will provide peer mentors with training on evidence-based

study techniques. When mentors study with their peers, their own learning is reinforced, so this is a win-win intervention!

Please note that peer mentoring is not the same as tutoring services offered by the Academic Success Center. A SAS peer mentor offers support to a fellow SAS classmate by sending reminders of important dates, offering to study with the student, and providing peer-based support and encouragement. #### **Academic Senate**

It has been a busy start to the semester for the College of the Siskiyous Academic Senate. Following the first Senate Meeting, senators generated a list of projects to be prioritized and completed this year. The list of tasks and priorities (unranked) is as follows:

- Promote the use of Open Educational Resources (OER) on campus
- Publish the Faculty Handbook as needed on the college website
- Create a Diversity, Equity, and Inclusion Guiding Document/Rubric through which we will focus
  decisions and actions throughout the year
- Address the topic of Department Chairs
- Create an Academic Integrity Statement and Plagiarism processes
- Student Survey
   identify modality that students prefer moving forward (online/hybrid/F2F); how about faculty?
- Utilize CARES act funding to help faculty meet Accessibility requirements
- Codify SLO/eLumen integration process
- Complete Program Review/Annual Update Cycle
- Continue working on and supporting Credit for Prior Learning
- Put forward faculty requests to replace faculty vacancies and add faculty to grow and develop programs
- Create, assess, and finalize a faculty orientation process
- Finalize the Program Approval Process
- Support the Nursing Program

In addition to creating a list of priorities and goals, in our September Academic Senate Meeting, our standing committees provided reports to the full senate.

The Distance Learning Committee Chair Maria Fernandez reported that the committee has met and members are finishing up projects from last year. Additionally, the committee is focusing its efforts on accessibility and equity in our online courses, utilizing OER, and identifying Zero Textbook Cost (ZTC) courses.

Curriculum Committee Chair Neil Carpentier-Alting reported that the committee continues to meet weekly. They will be reviewing curriculum that is up for review in the curriculum review cycle. Faculty whose courses need review will be notified by the committee, and the committee will assist instructors through the process if needed.

Flex Committee Chair Patrice Thatcher Stephens reported that Flex committee members are working collaboratively with administration. The Flex Committee discussed the number of required Flex days in our current calendar, and the amount of professional development and course/curriculum/outcome work that needs to be done. An optional Zoom Flex Day is scheduled for October 23<sup>rd</sup> 10-1:00. There will be a choice of 3 different three-hour blocks: Curriculum and Student Learning Outcomes, Canvas, and Diversity, Equity, and Inclusion.

Equivalency Committee Chair Andrea Craddock reported that the Equivalency Committee met to review minimum qualifications for adjunct instructors who will be teaching COS Courses in partnership with VERTO. The committee recommends a review of AP 7211 - Faculty Service Areas, Minimum Qualifications, and Equivalencies, in the near future.

SLO Committee Chair Neil Carpentier-Alting reported that the SLO committee is meeting weekly and members are preparing for the eLumen module configuration. There is an initialization period planned for the spring semester. Members of the SLO committee have volunteered to run their courses through the SLO assessment process. Any other faculty member who would like to do the same is welcome. Our OER liaison Jude Baldwin is pursuing the addition of the notation ZTC (zero textbook cost) to courses that use OER in the schedule. This is being mandated by the state. She noted that there is \$115 million in funding for California Community Colleges to use for ZTC projects provided they are in compliance with the mandate. She noted that we are not currently in compliance.

Lastly, we are committed to manifesting our Equity, Social Justice, and Anti-Racism Resolution in all of our work this year. Furthermore, we are committed to supporting the Board of Trustees in their efforts toward Diversity, Equity, and Inclusion as articulated in their resolution this past spring, and in their goals for the 2021-2022 school year. It is our hope that efforts toward creating instruction, curriculum, and classrooms that embody the spirit of our resolution and are observable and evident. We further hope that they contribute to a campus culture that embodies and embraces the tenets of diversity, equity, and inclusion.
