Happy Snowy New Year Siskiyous!

This week's quick updates:

- **Enrollment Report:** Can be accessed [here](#).
- **COVID Status:** We currently have 8 positive cases (7 students and 1 staff). We have also learned that a couple of staff members tested positive prior to returning to work from the Holiday Break. As with employees and students that contract COVID remotely (off-campus) and, have not been on-campus since contracting COVID, these cases are not emailed to the College community.
- **New COVID Manager:** Please join me in welcoming Jeanette Matheson! Jeanette's previous experience at College of the Siskiyous will prove beneficial to our COVID Mitigation efforts. We are more than thrilled that she has joined our team!
- **COVID Requirement Reminder:** Deadline to submit either proof of vaccine or weekly COVID test results is **Jan. 14th, 2022**. - **On-Campus COVID Testing Schedule:** The proposed on-campus COVID testing schedule is attached and currently being 'firmed-up' by our COVID Team. We will work diligently to make sure we can maintain this schedule. As with anything new being implemented, we anticipate some 'hiccups' and we appreciate your patience as we learn from the challenges to improve the process. If you have not been tested via the Color platform previously, we highly encourage you to pre-register to save time and avoid testing 'bottlenecks'. Pre-registration links can be accessed below:

- **Company Nurse:** Screening questions for both students and employees are now available on the Company Nurse platform. If you are working/attending classes on-campus, please complete the screening questions and once you receive an 'OK' screen (example attached), proceed to a check-in area to get your temperature checked and a wristband. Check-in areas are listed on the College's [COVID-19 webpage](#). Additionally, make sure any proof you have submitted (either vaccine or test results) are still appearing in your Company Nurse account.
- **New developments from CDC and OSHA:** CDC now recommends that people who test positive for COVID-19 stay home (isolate) for only 5 days. If, after 5 days of isolation, the individual is asymptomatic or symptoms are resolving, the individual may leave isolation

but should continue to wear a mask for another 5 days. Updated guidance can be accessed [here](#).

We can also anticipate an update from CalSOSHA regarding federal Occupational Safety and Health Administration ("OSHA") regulation that requires that employees at middle and large-sized companies (100 or more) either be fully vaccinated against COVID-19 or submit to weekly testing.
